**Pensions Circular 7 / 2006**

District Secretaries,  
Divisional Secretaries,  
Provincial Directors of Education,  
Zonal Directors of Education,  
Chief Incumbents of Pirivena,

**Inclusion of Service Periods of Pirivena Teachers**  
**for the Calculation of Pensions**  
**In Terms of Sections 8, 9, 10 of Pirivena Constitution.**

This circular is issued with concurrence to Circular No. 04/ 2004 of ED/ 1/ 8/ 1/ 153 and dated 16- 02- 2004 of Secretary to the Ministry of Human Resources Development, Education and Cultural Affairs.

02. In terms of Minutes on Pensions, casual, daily, temporary service periods of public officers shall take into account only for the purpose of pensions.

03. Accordingly, the approval is granted to include service periods which were not counted for pensions purposes of Pirivena teachers appointed under sections 8, 9, 10 of Pirivena Constitution. Contributions for such service periods should be recovered by the salaries corresponding to particular service period and sent to Department of Pensions. Contributions shall not recover for service periods which contributions already made.
