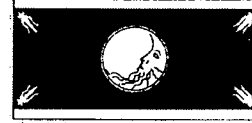

**Pension Circular 12/2009**

To all Secretaries to Ministries,  
Chief Secretaries of Provincial Councils,  
Heads of Departments,  
Commanders of Three Armed Forces,  
District Secretaries/ Divisional Secretaries,

**Revision of pension of government officers disabled  
due to accidents caused while on duty**

Following instructions are issued on revision of pension in compliance with regulations stipulated in Public Administration Circular 22/93 (IV) dated 29.12.2008, Public Administration Circular 386 dated 08.10.1986, Public Administration circular 22/93 dated 01.10.1993, Public Administration circular 21/88 dated 12.07.1988.

01. Pension of the officers who are disabled as a result of terrorist action and being paid salary till the age 55 years of age will be revised.

- i. Contributions towards widows' and orphans' pension should be recovered by the salary paid till 55 years of age.
- ii. Pension application/ pension application for revision should be forwarded based on the salary entitled at the completion of 55 years of age.
- iii. Service period till 55 years of age should be added.
- iv. Pension should be paid without gratuity based on the salary at the age 55 years and relevant service period.
- v. If retirement made on medical grounds and pension (without gratuity) being paid should be revised based on the salary payable at the age of 55 year and relevant service period.

02. Pension of the officers who are totally disabled as a result of terrorist action and being paid salary till the age 55 years of age will be revised. (Regulations are made under Public Administration Circular 22/93 (IV).

- i. Contributions toward widows' and orphans' pension should be recovered by the salary.
- ii. Pension should be calculated based on the salary and service period at the age off 55 years. (Pension should be paid without gratuity)
- iii. If retirement made on medical grounds and pension (without gratuity) being paid should be revised based on the salary entitled at the age of 55 year and relevant service period.
- iv. If a special compensation or a compensatory pension has been paid under Public Administration Circular 346 and 22/93, should be recovered. It is informed to contact Director General of Pensions to be aware of special compensations and compensatory pension paid to pensioner.

03. Since the officers who are not totally disabled as a result of terrorist actions are not paid salary till age of 55 years, their pension is not revised.

04. Instructions in this circular are not applicable for members in armed forces. Pension Circular 3/2009 should be applied for them.
