Pension Circular 02/2010

To all District Secretaries, Divisional Secretaries.

Payment of pension for officers in Health Service retired during 02.01.2001 – 01.12,2004

Officers in public service were granted salary increase with effect from 01.01.2004 reference to the Public Administration Circular 15/2003 dated 30.12.2003. However the salary increase was not applied for officers in health services since the increase was granted by General Circular 1-2/2004. The process of assigning pension numbers in 8 lakh segments was cancelled by Public Administration Circular No. 15 /2003 and issuing pension numbers in 9 lakh segment was initiated from 01.01.2004 by the Pension Circular No. 3/2004 dated 16.01.2004.

Officers retired from Health Service from 02.01.2004 to 01.12.2004 were not granted pension numbers in 9 lakh segment but they were granted numbers in 8 lakh segment in terms of Pension Circular 1/98.

Due to above action of issuing numbers in 8 lakh segment for officers retired from 02.01.2004 to 01.12.2004, some Divisional Secretaries have computed the pension having granted 10% salary increase in terms of Pension Circular 17/2003 dated 31.12.2003 effected from 01.01.2004 and some Divisional Secretaries have computed the pension by not granting this salary increase as per the instruction given by Pension Circular 17/2003 to grant this increase for the officers retired before 01.01.2004.

It is informed to grant 10% salary increase to the officers possessed with numbers in 8 lakh segment and retired from 02.01.2004 to 01.12.2004 in terms of the Pension Circular 17/ 2003 dated 31.12.2003.
