**Pension circular 04/ 2011 (Amendment II)**

District Secretaries/ Divisional Secretaries,

**Revision of pension allowance according to the budget proposals 2011**

Pension Circular 04/ 2011 dated 16.05.2011 and Pension Circular 04/ 2011 (Amendment I) dated 10.06.2011 issued by me regarding revision of pension in compliance to the government budget proposals 2011 is further amended by the addition of following instructions.

01. The date of retirement in the amended award letter of a revised pension should be based to make entitlement to this allowance.

Ex: Retirement date in first award letter is 01.01.2004  
Retirement date in amended award letter is 01.01.2006  
Accordingly the retirement date should be 01.01.2006

02. Since the all Local Government pensioners were retired before 03.09.1993 they are entitled to receive Rs.750 from 01.07.2011.

03. Persons entitled to receive only the dependency allowance are eligible to receive this allowance. If the dependency allowance is shared, this allowance should be equally shared as well.

04. The remarried widows who entitled to draw 50% of widows' pension in terms of Pension Circular 13/ 2010 are also eligible to receive this allowance in full.

05. The entitlement date to this allowance with regard to the recipients of widows' and orphans' pension should be the retirement date of the pensioner and the entitlement date for this allowance with regard to the officers died while in service should be the date which the officer died.
06. Please be informed that the entitlement date for this allowance should be the retirement date of the pensioner but not the date which commencing the payment of pension.
