MINUTES ON PENSIONS*

(Section 2 of Ordinance No. 2 of 1947 makes the Minutes on Pensions part of the "written law" of Ceylon from 1901)

General

PUBLIC servants have no absolute right to any pension or allowance under these rules, and the Crown retains the power to dismiss a public servant without compensation.

- 2. Subject to the exceptions and provisions hereinafter contained, every public servant holding a permanent office in the service of Ceylon, which has been declared to be pensionable by a notification published in the Government Gazette, may be awarded a pension as under, provided that no officer appointed after January 1, 1905, shall receive from all sources combined a pension exceeding £ 2,000 per applied to the public combined a pension exceeding £ 2,000 per applied to the public combined as pension and clearly per applied to the pension of this whole public combined both in Combined and clearly per applied to the pension of annum in respect of his whole public service both in Ceylon and elsewhere:
- (i) Any person who shall have served for one hundred and twenty months or less than one hundred and twenty-one months may receive an annuity equal to 180-720ths of the salary as defined hereinafter of the permanent office or offices held by him at the time of his retirement.
- (ii) Any person who shall have served for one hundred and twenty-one or less than one hundred and twenty-two months may receive an annuity equal to 181-720ths of such salary:
- (iii) In like manner, an addition may be granted of 1-720ths for each additional month of service until the completion of four hundred and twenty months of service when the maximum pension of 480-720ths of salary may be granted.

These rates include in each case a climate bonus of 60-720th, representing five years' service, granted for service in the tropics.

- (iv) Any person retiring on account of illness or age after completing one hundred and twenty months' gross service, but before completing one hundred and twenty months' service, counting for pension in accordance with section 10, may receive an annuity calculated on 720th as in the preceding sub-sections, but based on the actual number of months counting for service under that section, with an addition of the month for each complete period of two months of such service. addition of one month for each complete period of two months of such service.
- (v) Any person retiring on account of illness or age before completing one hundred and twenty months' gross service may receive a gratuity calculated at the rate of 1/12th of a month's salary of the permanent office or offices held by such person at the time of retirement, for each month of service.

Provided that a locally appointed nurse or matron of the Department of Health may retire at any time after she has completed ninety-six months' service without the medical certificate required by section 14, and in such cases may receive a gratuity limited to a maximum of twelve months' pay calculated at the rate of 1-12th of a month's salary for each month of service.

1 (ii) 2 Subject to the provisions of paragraph (iii), an officer who had exercised or who exercises the option referred to in sub-section (i) may, with effect from the date following the expiry of a period of twelve years and six months from the date of his retirement or from February 1, 1964, whichever date is the later, be paid the full pension or annuity which would have been paid to him had he not exercised such option:

Provided, however, that in a case where the date following the expiry of the period of twelve years and six months falls on a date other than the first day of a month, the date of commencement of such pension or annuity shall be the first day of the following month.

2 (iii) An officer who is granted a pension from a date later than the date of his retirement under section 15 of these Minutes and who had exercised or who exerreises the option referred to in the preceding provisions of this section may with effect from the date following the expiry of a period of twelve years and six months from the date from which his pension is granted or from February 1, 1964, whichever date is the later, be paid the full pension which would have been paid to him had he not exercised such option:

Provided, however, that in a case where the date following the expiry of the period of twelve years and six months falls on a date other than the first day of a month, the date of commencement of such pension shall be the first day of the following month.

- be exercised by the officer and the written notification in that behalf shall be transmitted to the Permanent Secretary, Ministry of Public Administration, Local Government and Home Affairs along with the application for pension.
- ³ (v) The option exercised by an officer under the preceding provisions of this section shall be irrevocable.
- "(vi) In the case of an officer who is of unsound mind or who by reason of illness or injury is rendered incapable of exercising a conscious choice, the option referred to in the preceding provisions of this sub-section may be exercised on his behalf by such person as the 'Permanent Secretary, Ministry of Public Administration, Local Government and Home Affairs in his discretion may decide.
- (6) Where a person is granted under these regulations both a gratuity and a pension, the amount of such pension shall be deemed, for the calculation of any deduction from the Ceylon pension which is required to bring it within the limits prescribed by sections 2 and 23 of these regulations to be the amount of the unreduced pension which might have been granted if the option of commutation had not been exercised.

- 2AB. (1) A retired public servant who at the time of his retirement held a permanent office" in the service of Ceylon but which had not at the time of his retirement been declared to be pensionable by notification published in the Gazette under section 2 of these Minutes may—

 - (b) the 'Permanent Secretary, Ministry of Public Administration Local Government and Home Affairs is satisfied that such office had not been declared to be pensionable prior to the retirement of such public servant owing to inadvertence,

be awarded such pension or gratuity as may have been awarded under these Minutes had such office been declared to be pensionable prior to the retirement of such public servant.

- (2) Where a retired public servant who at the time of his retirement held a permanent office in the service of Ceylon but which had not at the time of his retirement been declared to be pensionable by notification published in the Gazette under section 2 of these Minutes dies after retirement, and after his death such office is declared pensionable and the Permanent Secretary, Ministry of Public Administration, Local Government and Home Affairs is satisfied that such office had not been declared pensionable prior to the retirement of such public servant owing to inadvertence, then a gratuity equivalent to the amount of the pension or gratuity that may have been awarded under these Minutes to such deceased public servant had such office been declared pensionable prior to his retirement may be paid to his dependants in accordance with the provisions of section 39 of these Minutes.
- (3) There shall be deducted from any pension or gratuity payable under the preceding provisions of this section—
 - (a) the amount of any gratuity paid under these Minutes; or
 - (b) the amount of any award paid on account of bonus and subsidy under the provisions of the Public Service Provident Fund Ordinance, No. 18 of 1942.
 - (4) This section shall be deemed to have come into effect on January 1, 1946.

For the purposes of sections 2, 2AB and 2AC of the Minutes, the expression "permanent office" includes a post held by an employee who is eligible for permanency and consequent pension rights after a fixed period of service in a temporary capacity, if such post has been declared pensionable by a notification published in the Gazette.
 - *2B (1) If an officer confirmed in 'a pensionable post who has completed five years' public service (including any period of service on probation or agreement or under a local public body) dies while in service, such person or persons as may be approved by the 'Permanent Secretary, Ministry of Public Administration, Local Government and Home Affairs may be granted for the benefit of the dependants of the deceased officer—
 - (a) the commuted grauity which the deceased officer would have been entitled to under section 2 (A) (1) (i) of these Minutes had be exercised an option to commute his pension and retired on the date of his death; or
 - (b) a gratuity of an amount not exceeding one year's pensionable emoluments, whichever is the larger.
 - (2) In the case of an officer dying while seconded for service in Ceylon from the service of a Department of Her Majesty's Government, a death gratuity may be granted in the manner aforesaid. Should such an officer be eligible for a gratuity under the Imperial Superannuation Acts, the higher of the two gratuities shall be payable by the Government of Ceylon.
 - (3) On the death of any person to whom a pension has been granted which has not been reduced under the provisions of section 2A of these regulations, such person or persons as may be approved by the "Permanent Secretary, Ministry of Public Administration, Local Government and Home Affairs may be granted for the benefit of the dependants of the deceased pensioner a death gratuity not

exceeding the sum, if any, by which the total of the aggregate pension drawn and due falls short of the death gratuity which would have been payable if the deceased pensioner had been in service at the date of his death.

- ¹(4) There shall be deducted from the gratuity payable under the preceding provisions of this section in respect of a deceased officer any sum or sums due from that deceased officer to the Government or to the Lady Lochore Loan Fund.
- '(5) The provisions of paragraph (4) shall be deemed to have come into effect on October 1, 1951.
- ²3. Subject to the other provisions of these Minutes, the service of a public servant to be reckoned for pension or gratuity shall be the period of his service in his pensionable office or offices and such other service being service which is reckonable for purposes of pension or gratuity under these Minutes:

*Provided that—

- (1) a teacher who has been appointed to a post in the service of the Government prior to June 15, 1934, after a period of attendance at a training institution approved by the Permanent Secretary, Ministry of Public Administration, Local Government and Home Affairs may count for pension or gratuity half such period of training not exceeding two years; and
- (2) a teacher in the service of the Government on or before June 15, 1934, who was completed not less than 12 months full time service as an untrained teacher in a Government School, and has been granted leave of absence to attend a training institution approved by the Permanent Secretary, Ministry of Public Administration, Local Government and Home Affairs may count for pension or gratuity such period of training not exceeding two years,

if in each such case, the period of training is continuous with subsequent pensionable service as a Government teacher.

- ² 3A. (1) Subject to the provisions of sub-section (2), the following service or services shall be reckoned for pension or gratuity along with service in respect of which a pension or gratuity is payable under these Minutes, notwithstanding any interruption during or between any such services or between any such services and service in respect of which a pension or gratuity is payable under these Minutes:—
 - (a) service as a Superintendent of Village Works;
 - (b) service in an Education District Committee;
 - (c) service on the staff of the College and Hospital of Indigenous Medicine;
 - (d) service as a Gansabhawa clerk or peon in a Kachcheri or under a Village Tribunal remunerated from Gansabhawa funds;
 - (e) service remunerated from an Irrigation Fine Fund;
 - *(f) service under a Town Council, Village Council or Sanitary Board, of a midwife appointed to Government service under the Unified scheme for Midwives:
 - *(g) service as a Health Visitor in the Department of Health Services during the period commencing on October 1, 1953, and ending on March 31, 1954, being service remunerated from the Municipal Fund of the Colombo Municipal Council;
 - *(h) service in the Housing Loans Board (established by Act, No. 26 of 1949), remunerated from the Housing Loans Fund and service in the Department of National Housing, remunerated from the National Housing Fund where the services in the Department of National Housing is continuous with the services in the Housing Loans Board;

- (2) Where any period of service referred to in sub-section (1) has been terminated due to misconduct, the period or periods of service prior to the date of such termination shall not be reckoned for pension or gratuity payable under these Minutes.
- ¹(3) The provisions of item (k) of sub-section (1) shall not apply in the case of any person who while being an officer in the Tea Control Department or the Rubber Control Department had exercised the option to become a pensionable officer under Government only with effect from January 1, 1963.
- ¹3B. Service as an Honorary House Officer or as a Medical Intern ^a remunerated by an allowance shall, if such service is continuous with permanent service ^a or with acting service as a Government Medical Officer, be reckoned as service for any pension or gratuity payable under these Minutes.

- or periods of service that are reckoned as "Recorded Service" under regulation 2 (ix) of the School Teachers' Pension Regulations shall be reckoned for pension or gratuity payable under these Minutes along with service in respect of which a pension or gratuity is payable under these Minutes, notwithstanding any interruption during or between any such periods of service or between any such period of service and service in respect of which a pension or gratuity is payable under these Minutes.

Provided that—

- (a) where any such period of recorded service has been terminated due to misconduct the period or periods of recorded service prior to the date of such termination shall not be reckoned for pension or gratuity payable under these Minutes.
- (b) where contributions have not been made towards the pension in respect of any period of recorded service during which a teacher was liable to contribute in accordance with the provisions of regulation 5 of the School Teachers' Pension Regulations, the period of such recorded service shall be reckoned for pension or gratuity under these Minutes if and if only, such teacher makes payment of the contributions due for such period to the Director of Education.

- (c) where any teacher has been refunded the contributions made by him under regulation 5 of the School Teachers' Pension Regulations respect of any such period of recorded service, such period of recorded service shall be reckoned for pension or gratuity under these Minutes, if and if only, such teacher makes payment to the Director of Education of a sum equal to the contributions refunded to him.
- ¹3F. Notwithstanding anything to the contrary in these Minutes, the service of any public servant in the Tea Control Department or the Rubber Control Department from 1st January, 1961 to 31st December, 1962 shall, if followed by service in respect of which a pension or gratuity is payable under these Minutes be reckoned for any pension or gratuity payable under these Minutes, if and if only, the sum drawn by him as gratuity for the said period of service is refunded together with simple interest on such sum at four per centum per annum from the date he received payment of that sum.
- *4. The service of a public servant under sixteen years of age shall not be reckoned as service for purposes of pension or gratuity under these Minutes.

- 48' (1) Notwithstanding anything to the contrary in these Minutes, where any person who on completion of a period of training or apprenticeship under Government is immediately thereafter appointed to an office or post under Government for which such training or apprenticeship was a prerequisite, the period of such training or apprenticeship irrespective of the manner of remuneration during such period of training or apprenticeship, shall be reckoned as service for pension or gratuity under these Minutes if such person eventually retires from a pensionable diffice or post.
- (2) For the purposes of the preceding sub-section where a public servant who, on completion of this period of training or apprenticeship is unable to secure appointment to the post or office for which he had been trained or apprenticed due to circumstances beyond his control, but who is subsequently appointed to any office or post, then the break in service so caused shall be disregarded.
- 4c. (1) Notwithstanding anything to the contrary in these Minutes, where an apprentice of the Colombo Port Commission serves a period of apprenticeship under the Ceylon Government and a further period of sea-training on board foreign vessels, where such training is not provided by the Ceylon Government, which training is a prerequisite to his appointment to any such pensionable post in the Colombo Port Commission or in the Department of Merchant Shipping as is specified in Schedule J, the whole of the period of apprenticeship under the Ceylon Government irrespective of the manner of remuneration during such period, and the whole or any part of the period or periods of such sea-training as may be determined by the Permanent Secretary, Ministry of Public Administration, Local Government and Home Affairs shall be reckoned as service for person or gratuity under these Minutes. pension or gratuity under these Minutes.
- (2) For the purposes of sub-section (1), any interruption between the period of apprenticeship under the Ceylon Government and sea-training or between such sea-training and appointment to any such pensionable post in the Colombo Port Commission or in the Department of Merchant Shipping as is specified in Schedule J, shall be disregarded if the Permanent Secretary, Ministry of Public Administration, Local Government and Home Affairs is satisfied that such interruption was due to circumstances beyond the control of such apprentice.
- 5. Any public servant of Ceylon who may be appointed Governor-General of Ceylon shall, on relinquishing that appointment, if under the age of fifty-five years, be entitled to the same pension which he would have received had he continued to hold the office vacated by him when appointed Governor-General, and had he been obliged to retire on account of ill-health.
- 6. But if any such officer be offered other employment under the Crown which he may be reasonably expected to accept, the payment of his pension shall be suspended during the period of such employment if he accepts such offer. And if he declines the appointment offered to him, the payment of his pension shall be suspended until he attains the age of fifty-five years.

Abolition of Office

- 17. (1) In the case of abolition of office the pension or gratuity grantable to a public servant whose office has been declared to be pensionable will be as tollows :-
 - (i) If the officer has completed one hundred and twenty months' gross service he may be granted a pension of 1-720ths of his salary for each month of his service counting for pension in accordance with section 10, with an addition to such service of one month for each complete period of two months' service, the addition in no case exceeding one hundred and twenty months.
 - (ii) If the officer has not completed one hundred and twenty months' gross service he may be granted a gratuity of 1-12th of a month's salary for each month of service counting for pension in accordance with section 10, plus an addition of 50 per cent. thereon.
- (2) Provided always that the officer who is thus retired shall be liable to be recalled to the public service for re-employment, and that in no case shall the number of months to be added to the actual service exceed that which, if added to the age of the retiring officer, would bring that age up to sixty years.

Mode of Calculation of Pension, &c.

*8. (1) The pension or gratuity awarded to a public servant shall be computed upon the salary drawn by him at the time of his retirement in respect of the permanent office or offices, then held by him, provided that he shall have held such office or offices, or an office or offices, to which the same fixed salary or incremental scale of salary is attached, for at least three years, otherwise the pension shall be calculated upon the average of the salaries attached to the premanent offices. shall be calculated upon the average of the salaries attached to the premanent offices held by such person during the three years next preceding the commencement of such pension. Provided that where an officer retires within three years of his promotion to a higher class or grade, he shall have the option of claiming either a pension calculated in manner aforesaid or a pension calculated on the salary be would have been receiving had he not been promoted to the higher class or grade:

Provided further that—

- (i) the pension or gratuity payable to an officer of the Quasi-Clerical Service, who, at the time of retirement was paid a personal salary higher than the maximum of the scale of salary fixed for that Service shall be computed on the maximum of such scale and not on the personal salary of the defeat of the time of his actionment. such officer at the time of his retirement.
- (ii) the pension or gratuity payable to an officer of the Tea Control Department or the Rubber Control Department who had exercised the option to be awarded a pension under these Minutes, being an officer who at the time of his retirement was paid a personal salary higher than the maximum of the approved pensionable scale of salary attached to his post, shall be computed on the maximum of such approved pensionable salary scale and not on the personal salary of the officer at the time of his retirement;
- (iii) the pension or gratuity payable to any officer of the Department of Com-modity Purchase mentioned in Schedule I hereto, who at the time of his retirement was paid a personal salary higher than the maximum of the approved pensionable scale of salary attached to his post, shall be computed on the maximum of such pensionable scale of salary and not on the personal salary of that officer at the time of his retirement.

Provided further that the pension, gratuity or any other award payable to or in respect of any public servant who retires, sustains injury or dies after October 1, 1969, shall be determined on the hypothetical salary or wage, that would have been drawn by him, at the date of his retirement, injury or death, as the case may be, on the scale of salary or rate of wage that obtained on September 30, 1969.

- (2) The provisions of the second proviso to sub-section (1) shall-
 - (a) in so far as those provisions relate to the members of the Quasi-Clerical Service, be deemed to have come into effect on September 1, 1955; *
 - (b) in so far as those provisions relate to the officers of the Tea Control Department and the Rubber Control Department, be deemed to have come into effect on January 1, 1963; and

- (c) in so far as those provisions relate to the twenty-one officers of the Department of Commodity Purchase be deemed to have come into effect on January 1, 1958.
- ¹(3) The pension or gratuity payable to an officer of the Army Clerical Service shall, notwith standing anything to the contrary in the provisions of the amendments to these Minutes published in *Gazette* No. 13,608 of April 19, 1963, and in *Gazette* No. 14,135 of August 7, 1964, be computed, with effect from November 22, 1960, in accordance with the previous payable of the contraction o 1960, in accordance with the provisions of sub-section (1) of this section.
- ¹(4) For the purposes of this section, a public servant who has served as a Commissioner of Assize shall be deemed to have held a permanent office during his tenure of office as a Commissioner of Assize.
- ⁸8A. (1) Notwithstanding the provisions of section 8 and section 24 (2), where a public servant who has been seconded for service in a non-pensionable office in accordance with the provisions of these Minutes—
 - (a) retires from such office after it has been declared to be pensionable by a notification under section 2, such public servant shall-
 - (i) if he had held such office for a continuous period of less than three years, be paid a pension or gratuity based on the average of the salaries drawn by him in respect of the offices held by him during the three years immediately preceding the date of his retirement;
 - (ii) if he had held such office for a continuous period of not less than three years, be paid a pension or gratuity based on the salary drawn by him in respect of such office at the time of his retirement;
 - (b) retires from such office before it is so declared to be pensionable, such public servant may, at the discretion of the 'Permanent Secretary, Ministry of Public Administration, Local Government and Home Affairs, be paid a pension or gratuity according to the provisions of clause (ii) or clause (ii) of sub-paragraph (a) whichever is appropriate
- (2) The provisions of sub-section (1) shall be deemed to have come into effect on December 31, 1954.

Increase of Pensions

- *88. Notwithstanding anything to the contrary in these Minutes, the pension awarded to any public servant or to the dependants of any public servant under the provisions of these Minutes shall be increased in accordance with the provisions set out in Schedule F hereto.
- *8c. (1) Subject to the provisions of sub-section (2), where any public servant who retires or is retired on or after attaining the age of 55 years, in pursuance of the provisions of Public Administration Circular No. 2 of 1970, had received one or more promotions to a higher class, grade, service or post during the three years immediately preceding the date of his retirement, the pension payable to such public servant shall, notwithstanding the provisions of section 8(1) of these Minutes, be computed upon the salary drawn by him at the time of his retirement in respect of the permanent office held by him.
- (2) The provisions of this section shall apply to a public servant who had been promoted from a lower class, grade, service or post to a higher class, grade, service or post only in a case where the lower class, grade, service or post had been the contract of the provision of the contract of the contr the avenue of recruitment to such higher class, grade, service or post.
- (3) For the purposes of this section "salary" shall mean the hypothetical salary that would have been drawn by the public servant at the date of his retirement on the scale of salary that obtained on September 30, 1969.

- 9. (i) For the purpose of section '8 or section 8A salary includes personal allowance equivalent to salary, but no other emolument whatever.
- *(ii) In the case of European matron or nursing sister or any locally appointed matron or nursing sister or nurse of the Department of Health Services, the expression "salary" for the purposes of the last preceding section includes the annual value of the free Government quarters occupied by such matron, nursing sister or nurse; provided, however that no sum in excess of one-sixth of the annual salary of such matron, nursing sister or nurse shall be reckoned as such annual value.
- '(iii) The monthly allowance paid to a Village Headman, Kaddu Kangany or Wewa Lekama shall be deemed to be the salary for the purposes of this Minute.
- (iv) The provisions of sub-section (iii) shall, in so far as they relate to the allowance of a Kaddu Kangany or Wewa Lekama, be deemed to have come into effect on January 1, 1946.
- *(v) (a) In the case of any Medical Officer of the Department of Health Services, the expression "salary" for the purpose of section 8 of these Minutes shall include eighty per centum of the non-pensionable allowance paid in lieu of private practice to such Medical Officer:

Provided that where the non-pensionable allowance paid to such officer does not exceed Rs. 3,000 per annum, the expression "salary" shall include one hundred per centum of such non-pensionable allowance:

Provided further that-

- (i) where a Medical Officer has not drawn the non-pensionable allowance, or by reason of his promotion to a higher grade or post has not drawn the same fixed non-pensionable allowance for the 3 years next preceding the date of his retirement, the percentage addition to the salary on which such Medical Officer's pension will be computed shall be based on the average of the non-pensionable allowances drawn by him during the 3 years next preceding the date of his retirement; and
- (ii) where a Medical Officer has not received a promotion to a higher grade or post during the 3 years next preceding the date of his retirement and has not drawn the same fixed non-pensionable allowance during the 3 years next preceding the date of his retirement, the percentage addition to the salary on which such Medical Officer's pension will be computed shall be based on the non-pensionable allowance drawn by him at the date of his retirement.

'For the purposes of this sub-section, the expression "Medical Officer" shall include a Medical Officer of the Senior Administrative Grade and a Medical Officer of the Deputy Administrative Grade and any Medical Officer of the Department of Health Services who is appointed to the University of Ceylon to serve as a teacher or as an officer and who on his reirement becomes eligible to an award under these Minutes on terms of the Higher Education Act, No. 20 of 1966.

- (b) The preceding provisions of this sub-section shall be deemed to have come into effect on August 1, 1964.
- "(vi) In the case of any Apothecary of the Department of Health Services who was in service on August I, 1964, the expression "salary" for the purpose of section 8 of these Minutes shall include the appropriate pensionable allowance drawn by him on the date of his retirement:

Provided, however, that where such pensionable allowance or the same fixed pensionable allowance has not been drawn by him during the three years next preceding the date of his retirement, the pensionable allowance which shall be included in the salary on which his pension will be computed shall be the average of the pensionable allowances drawn by him during the three years next preceding the date of his retirement.

'(vii) In the case of any Dispenser of the Department of Health Services, the expression "salary" for the purpose of section 8 of these Minutes shall include the pensionable allowance of Rs. 7.50 per mensem drawn by him during the period commencing on January 1, 1966 and ending on April 30, 1968.

- 10. (i) No period during which an officer shall have been absent from duty on leave without salary shall be taken into account as service for computation of pension unless such leave shall have been granted on grounds of public policy.
- (ii) Only one half of any period during which an officer shall have been absent from duty on leave with half salary shall be taken into account as service for computation of pension unless such leave shall have been granted on grounds of public policy.
- (iii) Any period whilst an officer is proceeding to Ceylon on first appointment to the service thereof shall not be so taken into account unless he received not less than half salary from Ceylon funds in respect of that period.

Private Practice

- 11. (1) As a general rule, it is indispensable as a qualification for pension that the whole time of retiring officer during his employment shall have been given to the public service. But officers of the Attorney-General's Department, subordinate officers of the Department of Health, Headmen, Kaddu Kanganies and Wewa Lekamas shall not be affected by this provision.
- 2 (2) The provisions of sub-section (1) shall, in so far as they relate to Kaddu Kanganies and Wewa Lekamas, be deemed to have come into effect on January 1, 1946.

Deductions

- *12. (1) Where the explanation tendered by a public servant against whom, at the time of his retirement from public service, disciplinary proceedings were pending or contemplated in respect of his negligence, irregularity or misconduct, is considered to be unsatisfactory by the competent authority, the *Permanent Secretary, Ministry of Public Administration, Local Government and Home Affairs 'may either withhold or reduce any pension, gratuity or other allowance payable to such public servant under these Minutes.
- (2) Where any inquiry pending at the time of retirement of an officer from the public service, and concluded after such retirement, discloses any negligence, explanation tendered by him in respect of the findings of such inquiry is considered to be unsatisfactory by the competent authority or if no explanation is tendered by him in respect of the findings of such inquiry is considered to be unsatisfactory by the competent authority or if no explanation is tendered by him in respect of those findings, the *Permanent Secretary, Ministry of Public Administration, Local Government and Home Affairs may either withhold or reduce any pension, gratuity or other allowance payable or awarded to such officer under these Minutes.
- (3) Where no explanation has been tendered by a public servant referred to in paragraph (1) of this section, the Permanent Secretary, Ministry of Public Administration, Local Government and Home Affairs may request such public servant to tender an explanation.
 - 13. Repealed.

Age at which Pensions are granted

14. A pension will not be granted to a public servant who shall be under fifty-five years of age unless upon a certificate from the Head of his Department and from a Medical Board nominated by the Director of Health Services or, if the public servant is absent on leave, from such medical adviser or advisers as the Permanent Secretary, Ministry of Public Administration, Local Government and Home Affairs may name, that he is unfit to discharge the duties of his office

owing to infirmity either of mind or body. When a public servant claiming pension is himself the Head of a Department, a pension will be granted only upon medical certificate as prescribed above.

³ Provided that a pension may be granted without the medical certificate above referred to at the age of fifty years or after twenty years of service, whichever is earlier, in the case of locally appointed matrons ⁴, nursing sisters, nurses, midwives ⁵ and female vaccinators of the Department of Health, female teachers of the Education Department ^{6,7} and female employees in the Post and Telegraph Department ^{3,5} and at the age of forty-five or after fifteen years' service, whichever is later, in the case of members of the European Police Force.

Provided however that any member of the Police Service, or any officer of the Department of Public Security whose service in a pensionable and permanent post in that Department is continuous with service as a member of the Police Service may, on completing the age of fifty years, be granted, without the production of the medical certificate referred to in the preceding provisions of this section, a pension or gratuity computed in the manner set out in section 7 of these Minutes.

Retirement for Inefficiency

¹² 15. Where a public servant is required by the competent authority to retire on grounds of inefficiency, the ¹² Permanent Secretary, Ministry of Public Administration, Local Government and Home Affairs may in his discretion, grant such public servant a pension, gratuity or other allowance:

Provided, however, that the amount of pension, gratuity or allowance so granted shall in no case exceed the amount for which his length of service would qualify him.

Re-employment of Pensioner or Gratuitant

- ²² 16. (1) Where an officer to whom on his retirement a gratuity or a commuted gratuity together with a reduced pension has been granted, is re-appointed to a post under the Government, then such officer may be requested to refund to the Government such gratuity or commuted gratuity in such manner as the ²⁶ Permanent Secretary, Ministry of Public Administration, Local Government and Home Affairs may direct.
- (2) If any officer to whom a pension has been granted under these Minutes, is re-appointed to another post under the Government and subsequently retires in circumstances in which he may be granted a pension, then he may, in lieu of his previous pension, be granted a pension computed as if the periods of his service under the Government had been continuous, and such pension may be based on his pensionable emoluments at the time of his previous or final retirement from the service of the Government, whichever emoluments are the greater.

- (5) If any officer, to whom a gratuity has been granted under these Minutes, is re-appointed to another post under the Government and subsequently retires in circumstances in which he may be granted a pension or gratuity, then he may be granted a pension or gratuity computed as if the periods of his service under the Government had been continuous, and such pension may be based on his pensionable emoluments at the time of his previous or final retirement from the service of the Government, whichever emoluments are the greater. For the purpose of ascertaining whether the officer has the necessary qualifying service for a pension or gratuity his prior service under the Government shall be taken into account together with his re-employed service.
- (4) Nothing in these regulations shall prevent the Government of Ceylon from re-employing on a strictly non-pensionable basis, and without pension privileges of any kind in respect of the period of re-employment, an officer to whom a pension of gratuity has been granted under these regulations.

Compulsory Retirement

- 17. Every public servant may be required to retire from the public service on or after attaining the age of fifty-five years. Retirement shall be compulsory for every public servant other than a Judge of the Supreme Court on his attaining the age of sixty years, unless the competent authority decides that his services shall be retained.
- In the case of midwives and female vaccinators of the Department of Health, retirement shall be compulsory on attaining the age of fifty-five years unless the competent authority decides that the officer's services shall be retained.
- 17A. For the purposes of sections 12, 15 and 17, the expression "competent authority" means the authority competent to make appointments to the office held by any public servant referred to in those sections.
 - 118. Repealed.

Forfeiture of Pension on Conviction for certain Offences

- 19. If any person in the receipt of a pension or retiring allowance shall be convicted of any offence for which he shall be sentenced to death or to any term of rigorous imprisonment or analogous punishment exceeding twelve months, the payment of such pension or allowance shall be forthwith discontinued unless the Permanent Secretary, Ministry of Public Administration, Local Government and Home Affairs otherwise directs.
- 20. 11 (1) Subject to the exceptions contained in these Minutes, where the service of a pensionable public servant terminates due to voluntary resignation, vacation of office or dismissal on any ground, the period or periods of any service prior to such termination shall not be reckoned for pension or gratuity under these Minutes.

- 1 (2) Where the service under Government of a public servant has been interrupted by his voluntary resignation, the Permanent Secretary, Ministry of Public Administration, Local Government and Home Affairs may direct that the period of service of that public servant prior to his resignation be reckoned for the purposes of any pension or gratuity payable under these Minutes, if the Permanent Secretary, Ministry of Public Administration, Local Government and Home Affairs is satisfied—
 - (a) that such public servant resigned from Government service solely for the purpose of obtaining such higher professional qualifications as may be useful to him in connection with his work in the Department to which he was appointed after his resignation; and
 - (b) that such public servant, after obtaining such higher professional qualifications, re-joined Government service within such period as the Permanent Secretary, Ministry of Public Administration, Local Government and Home Affairs may, in the circumstances, consider reasonable.
- 2(3) Where any public officer or daily-paid employee who has been dismissed, or discontinued or retired for inefficiency from the public service is re-employed by the Government, the service of such officer or employee prior to such dismissal, discontinuance or retirement shall, notwithstanding anything to the contrary in these Minutes, be reckoned for the purposes of any pension or gratuity payable under these Minutes if, but only if—
 - (a) such service is otherwise admissible for pension or gratuity had the officer not been dismissed or discontinued or retired as aforesaid from the Public Service, and
 - (b) in the letter of appointment issued to such officer or employee on his re-employment, it is stated that such service will, if so admissible, be reckoned for the purposes of any pension or gratuity payable under these Minutes.
- * (4) Where any public servant who was the holder of a permanent and pensionable office in the service of the Government of Ceylon has been dismissed from the public service, such public servant may, if the *Permanent Secretary, Ministry of Public Administration, Local Government and Home Affairs is satisfied—
 - (a) that such public servant has been dismissed on any ground other than inefficiency, corruption, or misconduct involving moral turpitude,
 - (b) that the charges which resulted in his dismissal were framed under administrative regulations which were in force at the time of his dismissal but which are no longer in force, and
 - (c) that his re-employment in the service of the Government is not possible be treated as having retired from the public service as from the date of such dismissal and may be awarded at the discretion of the *Permanent Secretary, Ministry of Public Administration, Local Government and Home Affairs such pension or gratuity as might have been granted to him under these Minutes had he been retired on such date on the ground of ill-health.
- * (5) Where any public servant who was holding any pensionable post has resigned from the public service to accept the post of Private Secretary to a Minister appointed under section 46 (1) of the Ceylon (Constitution and Independence) Orders-in-Council, 1946 and 1947, is at any time thereafter appointed

to a pensionable post in the public service, the period of service of such public servant prior to such resignation shall, notwithstanding anything to the contrary in the preceding provisions of these Minutes, be reckoned for any pension or gratuity payable under these Minutes.

120A. (1) Where any public servant holding any pensionable office or post has earlier served as a daily-paid or as a temporary monthly-paid employee or as a permanent non-pensionable monthly-paid employee under the Government, the period or periods of such earlier service shall be reckoned for pension or gratuity under these Minutes, notwithstanding any interruption during any such service or between any such service or between any such service in such pensionable office or post:

Provided, however, that where any such period of daily-paid or temporary monthly-paid service or permanent non-pensionable monthly-paid service has been terminated due to misconduct, the period or periods of any service prior to the date of such termination shall not be reckoned for pension or gratuity under these Minutes.

(2) Where a public servant holding a pensionable office or post has had full-time acting service in any pensionable office or post, such acting service shall be reckoned for pension or gratuity under these Minutes, notwithstanding any interruption during such acting service or between such acting service and service in such pensionable office or post.

Pension Rights of Officers transferred to or from other Services under the Crown

- *21: (1) An officer transferred to or from the service of the Government of Ceylon from or to any other public service, whose aggregate service would have qualified him, had it been wholly under the Government of Ceylon, for a pension under these regulations, may, if he has served for a period of at least 12 months in a pensionable office under the Government of Ceylon, on his retirement from the public service in circumstances in which he is permitted by the law or regulations of the service in which he is last employed to retire on pension or gratuity, be granted a pension of such an amount as shall bear the same proportion to the amount of pension for which he would have been eligible had his service been wholly under the Government of Ceylon, as the aggregate amount of his pensionable emoluments during his service under the Government of Ceylon shall bear to the aggregate amount of his pensionable emoluments throughout his public service.
- (2) In determining for the purposes of this section the pension for which an officer would have been eligible if his service had been wholly in Ceylon—
 - (a) the final pensionable emoluments taken shall be those of his last period
 of service calculated in accordance with the law and regulations
 applicable thereto;
 - (b) no ragard shall be had to sections 7 and 30 of these regulations;
 - (c) regard shall be had to the condition that pension may not exceed twothirds of the final pensionable emoluments;
 - (d) no period of other public service under any Government, local public body or other employing authority which does not grant a pension or gratuity to the officer shall be taken into account.
 - (3) For the purposes of this section-
 - (a) The aggregate amount of his pensionable emoluments shall be taken as the total amount of salary which the officer would have drawn and the total amount of the other pensionable emoluments which he would have enjoyed had he been on duty on full-pay in his substantive office or offices throughout his period of public service subsequent to the attainment of the age of 16 years.

- Provided that in calculating the aggregate amount of his pensionable emoluments no account shall be taken of any service under any Government, local public body or other employment authority which does not grant the officer a pension or gratuity.
- (b) The expression "public service" includes employment in the colonial Audit Department (Home Establishment), or in the office of the Crown Agents for the Colonies, or under the High Commissioner for transport in Kenya and Uganda, or under a local public body in Ceylon which has adopted a scheme for payment of pension to its servants, or any such other employment as the 'Permanent Secretary, Ministry of Public Administration, Local Government and Home Affairs may determine to be "public service."
- (c) The words "to which he would have been entitled had the whole of his service been under the Government of Ceylon," shall be construed without regard being had to the limitation of £ 2,000 per annum of pension from all sources imposed by section 2.
- (4) Service as a Governor or High Commissioner of a British Dominion, Colony, or Protectorate, or a territory under British mandate, or as a Governor in India shall be deemed to be public service except for the purposes of computation of pension or gratuity and of section 23 and the proviso relating to maximum pension in section 2 of these Minutes.
- ² (5) Where an officer who has been transferred from other public service and whose aggregate service would have qualified him, had it been wholly under the Government of Ceylon, to retire on pension under these regulations, is compulsorily retired from the public service on abolition of office, he may if at the time he is in the service of the Government of Ceylon, be granted from the funds of Ceylon, in addition to the pension granted to him under this section, an addition to pension equivalent to that by which his pension calculated in accordance with section 2 would have been increased under section 7 by reason of abolition of office if his whole service had been under the Government of Ceylon.

Provided that the officer who is thus retired shall be liable to be recalled to the public service for re-employment.

- (6) An officer, who has been transferred to other public service from a pensionable post under this Government and has retired from other public service before completing ten years' public service in all in circumstances in which he is permitted by the law or regulations of the service in which he is last employed to retire on pension or gratuity, may be awarded a gratuity calculated in accordance with section 2 of these regulations based upon his salary and total length of service under the Government of Ceylon.
- *21A. (1) Notwithstanding anything to the contrary in these Minutes, but subject as hereinafter provided where any public servant who, being a Provident Fund contributor for a period of twelve months or more is appointed, with the consent of the Government to the Local Government Service or to the service of any local authority and retires therefrom from a pensionable post or office in circumstances entitling him to a pension or gratuity, he may, if his entire service would have qualified him, had it been wholly under the Government for a pension under these Minutes, be granted a pension of such an amount as shall bear the same proportion to the amount of pension for which he would have been eligible had his entire service been wholly under the Government as the aggregate amount of his pensionable emoluments during his service under the Government shall bear to the aggregate amount of his pensionable emoluments throughout his service

under Government and service in a local authority or authorities or in the Local Government Service provided he refunds to the Government, when required so to do by the 'Permanent Secretary, Ministry of Public Administration, Local Government and Home Affairs a sum equal to the bonus or award or other benefit paid to the credit of his account by the Government under section 14 of the Public Service Provident Fund Ordinance (Chapter 434), together with simple interest on such sum at four per centum per annum from the date he received payment of that sum.

- (2) In determining for the purposes of this section the pension for which a public servant would have been eligible if his service had been wholly under the Govern-
 - (a) no regard shall be had to sections 7 and 30 of these Minutes;
 - (b) the amount of pension payable shall not exceed two-thirds of his final pensionable emoluments;
 - (c) no period of service under Government or in any local authority or in the Local Government Service in respect of which no pension or gratuity is payable shall be taken into account.
- (3) Where a Provident Fund contributor referred to in sub-section (i) is unable to take up his appointment in the Local Government Service or in a local authority immediately after his release from Government service due to circumstances beyond his control, but takes up the appointment subsequently, the break so caused between his service under Government and his service in a local authority or in the Local Government Service as the case may be shall be disregarded.
 - (4) For the purposes of this section-
 - (a) the aggregate amount of pensionable emoluments shall be taken as the total salary drawn in the substantive office or offices during the service under Government and service in a local authority or authorities or in the Local Government Service and any other pensionable emoluments drawn in the substantive office or offices in the service of a local authority or authorities or in the Local Government Service subsequent to the attainment of the age of sixteen years:
 - Provided that in calculating the aggregate amount of pensionable emoluments no account shall be taken of any service under the Government or in a local authority or in the Local Government Service in respect of which no pension or gratuity is payable;
 - (b) "entire service" shall mean the total of-
 - (i) all periods of service under Government which would be admissible for pension or gratuity under these Minutes had the post or office he held prior to his appointment to the local authority or the Local Government Service been pensionable under these Minutes including ultimate service under Government as a Provident Fund contributor, and
 - (ii) all periods of service under the local authorities and in the Local Government Service admissible for pension or gratuity in accordance with any written law applicable thereto:
 - (c) "Provident Fund contributor" shall mean any contributor to the Public Service Provident Fund established by the Public Service Provident Fund Ordinance (Chapter 434), or any person who was liable to contribute to the aforesaid Fund but who had made no contributions to that Fund due to any reason whatsoever; and
 - (d) "Local Authority" shall mean a Municipal Council, Urban Council, Town Council or a Village Council.
- (5) The provisions of this section shall be deemed to have come into effect on April 1, 1946.
- 22. (Section 22 has been superseded by section 21 as appearing in Notification of August 21, 1934.)
- *23. (1) Whenever an officer entitled to a pension under these regulations is also entitled to a pension or pensions in respect of other public service, he may be granted the full pension for which he is eligible in respect of his service in

Ceylon, but no person may at any time draw from the funds of Ceylon an amount of pension which, when added to the amount of any pension or pensions drawn in respect of other public service, exceeds two-thirds of the highest pensionable emoluments drawn by such person at any time in the course of his service in Ceylon or in other public service, and in no case shall he be permitted to reckon service in Ceylon for a period that would make his total public employment in excess of forty years.

(2) In a case falling under the limitation laid down by sub-section (1) of this section, the amount of pension to be drawn from the funds of Ceylon shall be subject to the approval of the 'Permanent Secretary, Ministry of Public Administration, Local Government and Home Affairs' in order that it may be determined with due regard to the amount of any pension or pensions similarly to be drawn

in respect of other public service.

Seconded Officers

- 24. (1) Where any officer in the public service who is holding a permanent and pensionable post is seconded to a temporary post in the public service or to a post in the public service to which pension rights are not attached, the period of his service in the post to which he has been so seconded shall be reckoned for the purposes of any pension or gratuity payable under these Minutes, if—
 - (a) he retires under circumstances which would otherwise entitle him to a pension or gratuity;

(b) his secondment for such employment has been authorized by the appropriate authority; and

- (c) his secondment for such employment with claim to pension has been notified by the 'Permanent Secretary, Ministry of Public Administration, Local Government and Home Affairs in the Gazette.
- (2) Where any such officer as is referred to in sub-section (1) retires from service while holding the post to which he has been seconded or within a period of three years after leaving such post, the pension or gratuity payable to him shall be based on the pensionable emoluments of the last pensionable appointment or appointments held by him prior to retirement.

(3) The provisions of sub-section (1) and sub-section (2) of this section shall be deemed to have come into effect on July 1, 1957.

Supreme Court Judges

- *25. Pensions to Judges of the Supreme Court are grantable in accordance with the following regulations, but subject also to the provisions of such of the foregoing sections (e.g., sections 1, 2A, 2B, 5, 8, 10, 12, 14, 16, 17) as are not inconsistent with the following, viz.:—
 - ⁶ (i) A Judge of the Supreme Court, after not less than seven years' service in that capacity or in the capacity of Commissioner of Assize, who is compelled to retire on account of ill-health, or who has attained the age of fifty-five years, may be awarded a pension of ⁶ 1-240ths of his salary for each month of his service as such Judge until the maximum of ⁶160-240ths or two-thirds salary is attained after one hundred and sixty months' service.
 - (ii) A Judge of the Supreme Court, who before his elevation to the Bench has served the Crown in Ceylon in other capacities, and who has not less than ten years' service in Ceylon in all, including the time spent on the Supreme Court Bench, may be allowed to claim either a pension at the rate of '1-240ths of his salary as Judge of the Supreme Court for each month of his service in that capacity, together with 1-720ths of his pensionable salary previous to his elevation to the Bench for each pensionable month of his previous public service in Ceylon, with an addition to such service which shall bear the same proportion to five years as such service bears to his total public service in Ceylon, or a pension at ordinary pension rates, in accordance with section 2. for the whole of his service in Ceylon. 'Provided that in no case whether the pension is calculated by the first or second of the two methods shall the total pension exceed two-thirds of the Judge's salary.

- 1 (iii) A Judge of the Supreme Court who before his appointment as such Judge, has served the Government in the capacity of a legal officer and who has not less than ten years' service in the aggregate, including the period of service as a Judge of the Supreme Court, may be allowed to claim either a pension computed at the rate of 1/240ths of his salary as a Judge of the Supreme Court for each month of his service in that capacity together with 1/450ths of his pensionable salary prior to his appointment as such Judge for each pensionable month of his previous service as a legal officer, or a pension computed for the whole of his service under Government at the rate of 1/450ths of his salary drawn at the time of his retirement for each month of such service: Provided however that the total amount of pension so awarded in either case shall not exceed two-thirds of his salary as a Judge.
- (iv) Every Judge of the Supreme Court who is transferred to or from the service of Ceylon from or to other service under the Crown, and is not entitled to a pension under the foregoing sub-sections (i) and (ii), may, if his aggregate service under the Crown in Ceylon and elsewhere would have entitled him to a pension according to the principles laid down in these regulations, be awarded on his ultimate retirement a pension at the rate of 1.240ths of his salary as such Judge for each month of his service in that capacity.
- 3 (v) A Judge of the Supreme Court who is permanently appointed to the office of Attorney-General or any other pensionable office approved by the Governor-General shall be entitled to have his pension computed at the same rate and on the same basis as if he had continued to be a Judge of the Supreme Court.
- '(vi) The pension of a public servant who has served as a Commissioner of Assize or as an acting Judge of the Supreme Court shall be computed-
 - (a) if he retires prior to March 14, 1957, at the rate of 1/360ths, and
 (b) if he retires on or after March 14, 1957, at the rate of 1/240ths of his salary for each month of his service as a Commissioner of Assize or as an acting Judge of the Supreme Court.
- * (vii) Where a public servant or a legal officer retires from service while serving as an acting Judge of the Supreme Court or as a Commissioner of Assize, he shall be entitled to a pension computed in accordance he shall be entitled to a pension computed in accordance with the provisions of paragraph (ii) or paragraph (iii), as the case may be, of this section as though he had been a permanent Judge of the Supreme Court; and
- (viii) For the purposes of sub-sections (iii) and (vii) of this section, "legal officer" means any person holding or who has held any office or post specified in Schedule M of the Minutes on Pensions.

Permanent Secretaries or the Secretary to the Cabinet?

*25A. Awards to Permanent Secretaries or the Secretary to the Cabinet and their dependants may be granted in accordance with these Minutes, subject to the following provisions:

(i) Where a public servant is appointed to a post of Permanent Secretary or Secretary to the Cabinet' and eventually retired from the Public Service while holding that post, such appointment shall be deemed to be a promotion within the meaning of section 8 of these Minutes and the provisions of that section shall accordingly apply in regard to the calculation of pension.

(ii) Where the Governor-General transfers a Permanent Secretary who has ten suppointed from the Public Service to any other public office or at the request of such Permanent Secretary orders his reversion to the service, grade or office from which he was so appointed, his salary as Permanent Secretary shall be ignored for the purpose of these Minutes, and he shall be deemed to have continuously held during his period of service as Permanent Secretary the post or office, or as the case may be, to have continuously been during that period a member of the Service from which he was appointed as Permanent Secretary earning his increments in the normal manner. earning his increments in the normal manner.

- (iii) Where the Governor-General orders the transfer of a Permanent Secretary or Secretary to the Cabinet **(except at his own request)* and the Governor-General allows the request by such Permanent Secretary or Secretary to the Cabinet for retirement on special terms, he shall be granted an award in accordance with section 7 of these Minutes, but his salary as Permanent Secretary or Secretary to the Cabinet shall be ignored and he shall be deemed to have continuously held during the period of his service as Permanent Secretary or Secretary to the Cabinet the post or office, or as the case may be, to have continuously been during that period a member of the service from which he was appointed as Permanent Secretary or Secretary to the Cabinet and to have earned increments in the normal manner. increments in the normal manner.
- "(iv) Any public servant who was holding the post of Permanent Secretary on May 30, 1970, and who had not on that date attained the age of fifty-five years may, by written notice duly given to the Governor-General on or before August 31, 1970, elect to retire from the public service, and upon his retirement taking effect be granted a pension or gratuity of such amount as would have been awarded to him under section 7 of these Minutes if he had retired from the public services on abolition of common contractions. service on abolition of office.
- (v) The proviso regarding liability to be recalled to the Public Service for re-employment referred to in section 7 (2) of these Minutes shall not apply to a Permanent Secretary or Secretary to the Cabinet who has not been appointed from the Public Service.

Heads of Departments

*25s. Where a public servant, who is appointed to a pensionable post as the Head of a Department for a specified period, is not re-appointed, or does not desire re-appointment, to that post on the expiry of that period, he shall be deemed to have been retired and may be granted such pension or gratuity as might have been granted to him under these Minutes, if he had been retired on the ground of age or ill-health.

Judicial Officers

- *25c. (1) Any judicial officer retiring on account of illness or age before completing eighty-four months' gross service as such officer may receive a gratuity calculated at the rate of 1/12th of a month's salary for each month of such service.
- (2) Any judicial officer whose gross service as such officer is not less than eighty-four months but is less than eighty-five months may receive on his retirement a pension which is equivalent to 96/288ths of his salary at the time of his retirement. He may receive an addition of 1/288ths for each additional month of service in excess of the aforesaid eighty-five months until the completion of one hundred and eighty months of service when the maximum pension of 192/288ths of his salary at the time of his retirement may be granted.
 - 6 (3) Notwithstanding anything to the contrary in these Minutes
 - (a) any judicial officer appointed on any date prior to, or subsequent to October 1, 1959, to be a Judge of the Supreme Court or an acting Judge of the Supreme Court or a Commissioner of Assize; or
 - (b) any judicial officer transferred or appointed, on any date prior to, or subsequent to, October 1, 1959, to any other pensionable office under the Ceylon Government; and
 - 6 (c) each of the former judicial officers mentioned in Schedule K hereto, being an officer who subsequent to his resignation as a judicial officer was appointed to another pensionable office in the Government of Ceylon without a break in the continuity of his service under the Government,

may, if he was in service or in receipt of a pension on October 1, 1959, and if the total period of his service under the Ceylon Government in resepct of which a pension is payable to him is not less than 84 months, be entitled, subject to the provisions of section 8, to have his pension computed in accordance with the preceding sub-section as though he had been a judicial officer throughout the period of his service.

- (4) A judicial officer who, before his appointment to such office, has served the Grown in Ceylon in other capacities and who has not less than ten years' total service in Ceylon, including his service as such officer, may be granted a pension, calculated in accordance with section 2 for the whole of his service in Ceylon, or consisting of the following sums:—
 - (a) a sum which represents 1/288th of his salary at the time of his retirement for each month of his service as a judicial officer;
 - (b) a sum which represents 1-720ths of his pensionable salary in respect of his service in such other capacities for each month of such service; and
 - (c) a sum which represents a specified portion of his pensionable salary in respect of his service in such other capacities.

In this paragraph "specified portion" means a portion which bears the same proportion to sixty as the judicial officer's service in such other capacities bears to his total public service in Ceylon.

- (5) Notwithstanding anything to the contrary in sub-section (4), any judicial officer referred to in that sub-section shall not be entitled to receive thereunder a total pension in excess of two-thirds of his salary at the time to his retirement.
- 1 (6) Any retired judicial officer who was in receipt of a pension on October 1, 1959, shall be entitled to have any pension payable to him after that date calculated in accordance with the provisions of this section:

Provided, however, that, where any such retired judicial officer has exercised his option under section 2A (1) (i) of these Minutes to be paid in lieu of a pension, a pension at the rate of three-fourths of such pension, then, the pension payable to him after October 1, 1959, under this section, shall be reduced by an amount equal to one-fourth of the unreduced pension payable to him on the date of his retirement. For the purposes of this sub-section and of sub-section 7, the expression "retired judicial officer" means a person who retired while he was the holder of a permanent office in the Ceylon Judicial Service, and includes a person who retired from any office under the Ceylon Government to which he was appointed or transferred while he was the holder of a permanent office in the Ceylon Judicial Service.

- (7) Any 'retired judicial officer who has before October 1, 1959, received a gratuity under section 2A shall not be entitled after that date to claim the difference between the amount of the gratuity that he would have been entitled to had he retired after that date and the amount of the gratuity already paid to him.
- 1 (8) For the purpose of this section, the expression "judicial officer" shall mean a member of the Ceylon Judicial Service holding a permanent office in such service, and shall include a President of a Rural Court who received his permanent appointment to such post while being an Advocate or Proctor of the Supreme Court of Ceylon.

Legal Officers

- ² 25p. Notwithstanding anything to the contrary in section 2 of these Minutes but subject to the exceptions hereinafter provided, the following provisions shall apply in the case of the computation of the gratuity or pension payable to a legal officer:—
- (1) Any legal officer retiring on account of illness or age before completing one hundred and twenty months' gross service as such officer may receive a gratuity calculated at the rate of 1/12th of a month's salary for each month of service.
- (2) Any legal officer retiring on account of illness or age after completing one hundred and twenty months' gross service as such officer may receive a pension which is equivalent to 1/450ths of his salary for each month of his service as such officer until the maximum of 300/450ths or two-thirds of his salary is attained after three hundred months' service.
- (3) Any legal officer, who before his appointment as such officer has served the Government in any other capacity, and who has not less than ten years' gross service in the aggregate including his service as a legal officer, may receive either a pension at the rate of 1/450ths of his salary at retirement for each month of his

service as a legal officer, together with 1/720ths of his pensionable salary prior to his appointment as a legal officer for each month of his prior service with an addition to such service which shall bear the same proportion to five years as such service bears to his total service, or a pension computed in accordance with section 2 in respect of the whole of his service, whichever is the greater:

Provided that in no case whatsoever, shall the total pension payable to any officer exceed two-thirds of the salary of the officer at retirement.

- (4) The preceding provisions of this section shall not apply in the case of any legal officer who retires under the provisions of the Treasury Circular No. 700 dated 4th September, 1966, on the ground that he is unable to work in the Sinhala Language, and in every such case, the provisions of section 2 for the time being in force shall apply.
- (5) For the purposes of this section, "legal officer" means any person holding any office or post specified in Schedule M.
- (%) Subject to the preceding provisions of this section, the other provisions of these Minutes shall apply to a legal officer in like manner and to the like extent as they apply in the case of any other officer of the public service.

Special Departments

- 126. (i) The officers of the Survey and Irrigation Departments appointed on or after August 15, 1928, who are specified in Schedule C, may receive 30-720ths of the salary on which their pension is computed, in addition to the rates laid down in section 2, irrespective of the age of retirement and whether retirement is on medical certificate or not. Officers of the Survey Department appointed prior to August 15, 1928, who are specified in Schedule C, may be granted either 60-720ths of the salary on which their pension is computed, in addition to the rates laid down in section 2, if they retire on medical certificate before attaining the age of fifty-five, or an addition of 30-720ths of the salary on which their pension is computed irrespective of age and whether such retirement is on medical certificate or not. Officers of the Irrigation Department appointed before August 15, 1928, who are specified in Schedule C, may be granted 69-720ths of the salary on which their pension is based, in addition to the rates laid down in section 2, irrespective of the age of retirement and whether retirement is on medical certificate or not. In the case of the Surveyor-General, Deputy Surveyor-General* and Assistant Surveyor-General, this privilege will be allowed only when those officers have been appointed in the course of departmental promotion and not when they have been brought in from outside. Nothing in this sub-section shall be so construed as to make an officer eligible for a pension before he would be otherwise eligible.
- (ii) An officer who has served in more than one department will be eligible in respect of his service in each department in which he was qualified for an addition under the immediately preceding sub-section for an addition which shall bear the same proportion to the addition which he might have received if the whole service had been in that department as his service in such department bears to his total service.
 - (iii) Repealed.
- 1(iv) Sergeants-Major, sergeants, and constables of the Police Force, who at the time of their retirement are in receipt of a good service allowance of Rs. 15 per mensem may receive an addition of Rs. 15 per mensem to any pension which they may be awarded under this Minute.
- '(v) Sergeants and Guards of the Excise Department, who at the time of their retirement are in receipt of a good service allowance of Rs. 5 per mensem, may receive an addition of Rs. 5 per mensem to any pension which they may be awarded under these Minutes.
- 7(vi) All persons of whatever grade (employed in the Railway Department) are liable to summary dismissal (without or with reduced pension), suspension, or reduction for inefficiency or misconduct.

'(vii) Medical Officers of the Department of Health Services retiring on or after August 1, 1964, on attaining the age of fifty-five years or on grounds of ill-health before attaining the age of fifty-five years, may be granted 30-720ths of the salary on which their pension is computed in addition to the rates laid down in section 2 of these Minutes:

Provided that the preceding provisions of this sub-section shall not apply to-

- (a) Medical Officers of the Department of Health Services who retire under the provisions of section 48HB (1) of these Minutes;
- (b) Medical Officers of the Department of Health Services who retire on or after September 4, 1966, under the provisions of section 48M of these Minutes; and
- *(c) Medical Officers of the Department of Health Services in the cadre of Specialists who retire on or after February 1, 1972 under the provisions of section 48HC of these Minutes.

Gratuities to Daily-paid Employees

29. *(1) Any daily-paid employee with an aggregate service of ten years or more may, if it appears from the report of a Medical Board, to be nominated by the Director of Health Services, that he is physically unfit to discharge the duties of his office owing to infirmity either of mind or body, be awarded a gratuity calculated at the rate of 1-12th of a month's pay for each complete month of service. In a case where any such employee has attained the age of fifty-five years. *no Medical Board shall be required but the Head of the Department shall be required to furnish proof that the employee is not under fifty-five years of age. proof that the employee is not under fifty-five years of age.

- (2) For the purposes of the preceding sub-section, "aggregate service" in relation to any employee shall mean a period of continuous service of an aggregate of non-continuous periods of service: Provided, however, that where any period of such service has been terminated due to misconduct on the part of such employee, the period or periods of his service prior to the data of such termination shall not be reckoned for any gratuity.
- (3) In the case of a daily-paid employee who dies whilst still in the service and who at the time of his death would, if he had retired, have been eligible for a gratuity under this section, the gratuity that would, in the ordinary course, have been paid to him had he retired may be paid to his widow or next-of-kin.

Enhanced Pensions, &c., in Cases of Injuries received in Discharge of Duty

- ¹29A. (i) Section 30, 31 and 31A of these Minutes are not applicable to persons entitled to compensation under the Workmen's Compensation Ordinance, No. 19 of 1934, or to their dependants if such persons were newly appointed to the service of the Government of Ceylon on or after the date on which that Ordinance came into operation: Provided that a person with service prior to that date under the Government of Ceylon shall not be deemed to have been newly appointed for the purposes of this section if pension, retiring allowance or gratuity under these regulations, or benefits under a Provident Fund established by the Government of Ceylon are payable in respect of such prior service.
 - (ii) In the case of persons entitled to compensation under the said Ordinance, and not newly appointed as aforesaid, and the dependants of such persons, sections 30 and 31 of these Minutes are not applicable except as provided in section 30 (iv).
 - ²30. (i) Subject to the provisions and exceptions contained in the preceding section when a public servant or daily-paid employee is rendered permanently incapable of contributing to his support, either wholly or partially, by reason of an injury received—
 - (a) in the actual discharge of his duty,
 - (b) without his own default.
 - (c) being an injury specially attributable to the nature of his duty,

he may be granted in respect of such injury an annual allowance not exceeding the under-mentioned portion of his salary at the date of the injury, viz:

When his capacity to contribute to his support is slightly impaired, 5-60ths. Impaired, 10-60ths.

Materially impaired, 15-60ths.

Totally destroyed, 20-60ths.

- (ii) The award shall be so much less than the amount grantable under the scale given above as the Permanent Secretary, Ministry of Public Administration, Local Government and Home Affairs shall order in case—
 - (a) The usual amount exceeds by not less than Rs. 1,000 a year the rate of retired allowance to which the length of the injured man's service would entitle him; or
 - (b) The injured man has continued to serve for not less than one year after the injury in respect of which he retires; or
 - (c) The injured man is 50 years of age or upwards at the date of injury; or
 - (d) The injury is not the sole cause of retirement; i.e., retirement is caused partly by age or infirmity.
- (iii) The above award shall be in addition to the pension or the retiring allowance, or gratuity to which the injured man would be qualified by length of service: Provided that no award shall together with such pension or retiring allowance exceed 50/60ths of his salary at the date of the injury: Provided further that if the officer continues in service after the injury, and the grant of an ordinary pension or retiring allowance is consequently postponed until final retirement or if an officer once retired with an injury allowance is re-employed, the limitation shall be 50/60ths of his salary at date of final retirement or at date of injury, whichever is greater.

- (iv) In the case of a pensionable officer, who not having completed ten years' gross service, is entitled only to a gratuity he may, if he wish it, be awarded in lieu of such gratuity, an annual allowance of so many 720ths as the months he has actually served, together with the number of 60ths that may be awarded as above on account of his injuries. An annual allowance on account of his service as provided in this sub-section may be granted to an officer in a pensionable office who is entitled to compensation under the Workmen's Compensation Ordinance, No. 19 of 1934, in addition to such compensation.
- 30 A¹ (1) Notwithstanding anything to the contrary in these Minutes, but subject as hereinafter provided, where a public servant or daily-paid employee suffers permanent total disablement as a result of an injury received—
 - (a) in the actual discharge of his duties:

(b) without his own default; and

(c) on account of circumstances specifically attributable to the nature of his duties:

then, he may be granted by way of compensation in respect of such disablement, an amount equal to thirty months' basic salary or basic wages of such public servant or daily-paid employee or ten thousand rupees, whichever is greater.

- (2) The amount of compensation payable in respect of the disablement of a public servant or daily-paid employee under sub-section (1) of this section shall be in addition to any allowance granted in respect of such disablement under section 30 of these Minutes or any benefits granted under the Workmen's Compensation Ordinance (Chapter 139), as the case may be.
- (3) No public servant or daily-paid employee shall be entitled to compensation under this section unless a duly constituted medical board appointed for the purpose by the Director of Health Services has examined him and has issued a written report to the effect that such public servant or daily-paid employee has suffered permanent total disablement as a result of an injury referred to in sub-section (1) sub-section (1).
- (4) Where a public servant or daily-paid employee who is eligible for compensation under this section in respect of permanent total disablement resulting from an injury dies before compensation is paid, then the compensation due to him shall be paid to his dependants in the manner provided in section 31C of these Minutes as if such public servant or daily-paid employee had died as a result of such injury.
- (5) For the purposes of this section "permanent total disablement" shall mean such disablement of a permanent nature as incapacitates a public servant or dailypaid employee for all work which he was capable of performing at the time of the injury which resulted in such disablement:

Provided that permanent total disablement shall be deemed to result from the permanent total loss of the sight of both eyes or from any combination of injuries specified in the table set out in section 31A of these Minutes in a case where the aggregate percentage of the loss of earning capacity, as specified in that table against those injuries, amounts to one hundred per cent.

- (6) The provisions of this section shall not apply to any police officer (including a police driver), who is eligible for compensation in respect of disablement under any regulations made under the Police Ordinance (Chapter 53).
- (7) This section shall be deemed for all purposes to have come into force on the twenty-ninth day of January, 1964.
- *31. (1) Subject to the provisions and exceptions contained in section 29A, where a public servant or a daily-paid employee dies as a result of injuries received-
 - (a) in the actual discharge of his duty,(b) without his own default, and

(c) on account of circumstances specifically attributable to the nature of his duty,

while in the service of the Government of Ceylon, there may be granted in addition to the gratuity, if any, made to the dependants of such public servant or daily-paid employee under sections 2B, 29 and 44—

(ii) if the public servant of ally-paid employed leaves a widow, to whom a pension is granted under paragraph (i) and a child or children, a pension in respect of each child, untill such child attains the age of eighteen years, of an amount not exceeding one-eighth of the pension prescribed by that paragraph;

(iii) if the public servant or daily-paid employee leaves a child or children, but does not leave a widow or no pension is granted to the widow, a pension in respect of each child until such child attains the age of eighteen years, of double the amount prescribed by paragraph (ii);

- (iv) if the public servant or daily-paid employee leaves a child or children and a widow to whom a pension is granted under this sub-section, and the widow subsequently dies, a pension in respect of each child as from the date of the death of the widow until such child attains the age of eighteen years, of double the amount prescribed by paragraph (ii) of this sub-section:
- (v) if the public servant or daily-paid employee does not leave a widow, or if no pension is granted to his widow, and if his mother was wholly or mainly dependent on him for her support, a pension to the mother, while of good character and without adequate means of support, of an amount not exceeding the pension which would have been granted to his widow if he had left a widow:

Provided that-

- (1) if the public servant or daily-paid employee had not attained the age of forty-five years at the date of the injury, his annual pensionable emoluments at that date shall be deemed to be the annual pensionable emoluments which in the opinion of the Permanent Secretary, Ministry of Public Administration, Local Government and Home Affairs, he would have drawn at the date on which he would have attained that age or twenty years after the date of the injury, whichever is the earlier in case he had remained so long in the service of the Government of Ceylon;
- (2) except where the provisions as to the minimum pension of Rs. 200 a year apply, the pension to the widow under this sub-section shall not exceed one-half of the public servant's or daily-paid employee's pensionable emoluments at the date of the injury;
- (3) a pension shall not be payable under this sub-section at any time in respect of more than six children;
- (4) in the case of a pension granted to a mother, if the mother is a widow at the time of the grant of the pension and subsequently remarries, such pension shall cease as from the date of remarriage; and if at any time it appears to the Permanent Secretary, Ministry of Public Administration, Local Government and Home Affairs, that the mother is adequately provided with other means of support, such pension shall cease on such date as the Permanent Secretary, Ministry of Public Administration, Local Government and Home Affairs may determine;
- (5) a pension granted to a female child under this section shall cease upon the marriage of such child notwithstanding that she may be under the age of eighteen years.
- (2) For the purpose of deciding what pensionable emoluments a public servant, or daily-paid employee, who had not attained the age of forty-five years at the date of the injury, would have drawn, it shall be assumed that he would have passed all efficiency bars and would have received all normal promotions, including promotions from class to class whether such promotions are dependent on the occurrence of vacancies or not; but it shall not be assumed that he would have received any special promotions or promotions dependent upon the passing of examinations other than examinations prescribed for promotion over efficiency bars.
- (3) The House of Representatives may by resolution make an award under subsection (1) of this section in any special case if, notwithstanding that the provisions of paragraph (c) of that sub-section are not satisfied, the House of Representatives is of opinion that, having regard to the circumstances in which the injury was received or to the need of the dependants of the public servant or daily-paid employee, such an award should be made.

- (4) In the case of a public servant or daily-paid employee, who does not hold a pensionable office, the expression "pensionable emoluments" in the preceding sub-sections shall mean the emoluments enjoyed by him which would have been pensionable emoluments if the office held by him had been a pensionable office.

 - (a) a posthumous child,
 - (b) a step-child or illegitimate child born before the date of the injury and wholly or mainly dependent upon the public servant or daily-paid employee for support, and

THE SCHEDULE

A .-- Where permanent total disablement results from the injury-

- (1) In the case of an adult, a sum equal to forty-two months' wages or three thousand five hundred rupees, whichever is less; and
- (2) In the case of a minor, a sum equal to eighty-four months' wages or three thousand five hundred rupees, whichever is less; and

B.—Where permanent partial disablement results from the injury—

- (1) In the case of an injury specified in the table, such percentage of the compensation which would have been payable in the case of permanent total disablement as is specified therein as being the percentage of the loss of earning capacity caused by that injury; and
- (2) In the case of an injury not specified in the table, such percentage of the compensation payable in the case of permanent total disablement as is proportionate to the loss of earning capacity permanently caused by the injury.

C .- Where death results from the injury --

- (1) In the case of an adult, a sum equal to thirty months' wages or two thousand five hundred rupees, whichever is less; and
- (2) In the case of a minor, two hundred rupees.

For the purpose of construing this schedule-

- (a) "Adult" and "minor" shall mean respectively a person who is not and a person who is under the age of fifteen years.
- "Permanent total disablement" shall mean such disablement of a permanent nature as incapacitates an officer or employee for all work which he was capable of performing at the time of the accident resulting in such disablement: Provided that permanent total disablement shall be deemed to result from the permanent total loss of the sight of both eyes or from any combination of injuries specified in the table where the aggregate percentage of the loss of earning capacity as specified in that table against those injuries amounts to one hundred per cent that table against those injuries amounts to one hundred per cent.
- (c) "Permanent partial disablement" shall mean such disablement of a permanent nature as reduces the earning capacity of the officer or employee in every employment which he was capable of undertaking at that time:

Provided that every injury specified in the table shall be deemed to result in permanent partial disablement; and where more injuries than one are caused by the same accident, the amount of compensation payable for permanent partial disablement shall be aggregated, but not so in any case as to exceed the amount which would have been payable if permanent total disablement had resulted from the injuries.

(1) If an officer proceeding by an approved route to or from Ceylon at the commencement or termination of his service therein, or of a period of leave therefrom, is injured or dies as the result of damage to the vessel or vehicle in which he is travelling or of any act of violence directed against such vessel or vehicle, and the *Permanent Secretary Ministry of Public Administration, Local Government and Home Affairs is satisfied that such damage or act is attributable to circumstances arising out of any war in which Her Majesty may be engaged, such officer shall be deemed to have been injured or to have died, as the case may be, in the circumstances described in section 30 (i) or section 31 (i).

- *31c. (1) Notwithstanding anything to the contrary in these Minutes, but subject as hereinafter provided, where any public servant or daily-paid employee dies as a result of an injury received—
 - (a) in the actual discharge of his duties;
 - (b) without his own default; and
 - (c) on account of circumstances specifically attributable to the nature of his duties;

then, there may be granted by way of compensation in respect of such death, an amount equal to thirty months' basic salary or basic wages of such public servant or daily-paid employee or ten thousand rupees, whichever is the greater, in the following manner:—

- (i) if the public servant or daily-paid employee leaves a widow and children, such amount shall be paid in the proportion of one-half to the widow and the other half in equal shares to the dependent children;
- (ii) if the public servant or daily-paid employee leaves a widow but does not leave any dependent children, the entirety of such amount shall be paid to the widow;
- (iii) if the public servant or daily-paid employee leaves a dependent child or children but does not leave a widow, such amount shall be paid to the child or to the children in equal shares;
- (iv) if the public servant or daily-paid employee does not leave a widow or any dependent child, such amount shall be paid to any other dependant or dependants of the deceased in such manner as the Permanent Secretary, Ministry of Public Administration, Local Government and Home Affairs may determine.

- (2) The amount payable under this section in respect of the death of a public servant or daily-paid employee shall be in addition to any pension or pensions payable in respect of such public servant or daily-paid employee under section 31 of these Minutes or any benefits payable under the Workmen's Compensation Ordinance (Chapter 139), as the case may be.
- (3) For the purpose of this section, the expression "child" shall include a stepchild or an adopted child, adopted in a manner recognized by law.
- (4) The provisions of this section shall not apply to any police officer (including a police driver) in respect of whose death compensation is payable under any regulations made under the Police Ordinance (Chapter 53).
- (5) This section shall be deemed for all purposes to have come into force on the twenty-ninth day of January, 1964.

Extended Service of Officers engaged under Special Agreements

- 32. (i) Whenever an officer who has been serving the Government on a special agreement for a fixed term of service remains in the service of the Government after the expiration of that term without any fresh agreement, or without express renewal for a definite term of his previous agreement, as a member of a permanent Department under Government, holding an office declared pensionable by notification, such officer thereby ceases to be entitled to the stipulations made in his favour in the original agreement.
- '(ii) No service on probation or agreement shall count for pension unless without a break of service the officer is confirmed in his appointment in Ceylon or in other public service. A period of service on probation or agreement when continuous with subsequent permanent service which has been declared to be pensionbale may, however, be reckoned for pension.

Medical Boards and Pensions or Gratuity Papers

- 35. (i) Medical Boards on officers drawing less than Rs. 4,260° per annum are nominated by the Director of Health Services, to whom application should be made direct by Heads of Departments. The Director of Health Services will report to the Permanent Secretary to the Ministry charged with the administration of the function of his Department any case in which he considers application has been made unnecessarily.
- (ii) When the Head of a Department considers that any of his officers drawing Rs. 4.260° or over should be retired on the ground of ill-health, he must apply to the Permanent Secretary to the Ministry charged with the administration of the function of his Department for the appointment of a Medical Board. If the Department is not grouped under a Ministry the application must be made direct to the Director of Health Services.
 - (iii) Applications for Medical Boards should be made on form General 142.
- 36. In all cases the Director of Health Services will forward the report of the Medical Board with his own comments direct to the Head of the Department concerned.
- 37. If the officer reported on is condemned by the Board, the particulars necessary for the computation of his pension (on form General 55) together with the report of the Board, must be forwarded direct to the Permanent Secretary, Ministry of Public Administration, Local Government and Home Affairs.
- 38. The same course with regard to superannuation papers must be followed where an officer retires on account of age.
- *38A. The application for pension or gratuity in respect of any pensionable public servant who with the approval of Government has accepted employment as a full-time member of a statutory body or as an officer or servant of a statutory body or on the staff of a statutory body and who is entitled to a pension or gratuity under these Minutes, shall be forwarded by such statutory body to the *Permanent Secretary, Ministry of Public Administration, Local Government and Home Affairs.

"statutory body" shall mean a Corporation, Board, University or any other institution established by statute; and

"full-time member" shall have the same meaning as in section 48A of these Minutes.

Payment of Pensions of Deceased Pensioners

- 39. (1) A pension or an allowance awarded under these Minutes shall be payable up to the end of the month in which the pensioner dies.
- ² (2) Any unpaid commuted gratuity, undrawn pension or allowance due to a deceased pensioner shall, except in cases where the disposal thereof has been specifically willed by the deceased, be payable in the manner set out in paragraph (3).
- ²(3) (i) Where a male pensioner dies leaving a widow and children, one half of the unpaid commuted gratuity, undrawn pension or allowance due to such pensioner shall be paid to the widow and the other half shall be paid to his legitimate children in equal shares. If any legitimate child of the pensioner predeceases him leaving issue, the share of such child shall be paid to the issue of such child in equal shares. Where the deceased pensioner dies leaving a widow or legitimate children, the entirety of such gratuity, pension or allowance shall be paid to such widow or children, as the case may be. Where the deceased pensioner dies leaving no widow or children, such gratuity, pension or allowance shall be paid to the heirs of the deceased according to the law of intestacy applicable to the case.
- *Provided that the preceding provisions of this paragraph shall not apply to a male pensioner who is a Muslim.
- *(ii) Where a male pensioner, being a Muslim, dies leaving a widow or more than one widow and legitimate children, one half of the unpaid commuted gratuity, undrawn pension or allowance due to such pensioner shall be paid to the widow or to the widows in equal shares, and the other half shall be paid to such children in equal shares. If any such child predeceases him leaving issue, such child's share shall be paid to the issue of such child in equal shares. Where the deceased pensioner dies leaving only a widow or more than one widow, or only legitimate children, the entirety of such gratuity, pension or allowance shall be paid to the widow or to such widows in equal shares, or, as the case may be, to such children in equal shares. Where the deceased pensioner dies without leaving any widow or legitimate child, such gratuity, pension or allowance shall be paid to the heirs of the deceased according to the law of intestacy applicable to the case.
- ² (iii) Where a female pensioner dies the entirety of the unpaid commuted gratuity, undrawn pension or allowance due to such female pensioner shall be paid to her children and in the absence of children to her legal heirs according to the law of intestacy applicable to the case.

Payment of Pensions and Gratuities due to Persons who are of Unsound Mind

- *39a. (1) Where the *Permanent Secretary, Ministry of Public Administration, Local Government and Home Affairs is satisfied, either on the report of a duly constituted Medical Board or on the certificate of a registered medical practitioner and that of a Justice of the Peace, that a public servant or any other person to whom a pension or gratuity has been or is to be awarded is of unsound mind, he may—
 - (a) in a case where a Court of competent jurisdiction has appointed a person to be in charge of such mentally disabled person pay such pension or gratuity to the person so appointed to be applied for the maintenance of the mentally disabled person and his family, and
 - (b) in a case where no such appointment has been made, pay such portion of the pension or gratuity as he may think fit to the institution or person having the care of such mentally disabled person and the balance to the dependants of such person.
- (2) The provisions of sub-section (1) shall be deemed to have come into effect on January 1, 1940.

Miscellaneous

- 140. (i) When an officer has been reduced for misconduct and subsequently reinstated, if the reinstatement took place three years before his retirement, his pension will be calculated on his actual salary without deduction; if the reinstatement took place within three years of the retirement, the pension will be calculated on the average salary for the three years.
- (ii) If an officer reduced for misconduct has not been reinstated, his pension will be calculated on his actual final salary, even though the reduction was made within three years of retirement but no further reduction will be made save in very exceptional circumstances in which the misconduct has been very serious, or the punishment inflicted inadequate.
- *(iii) In the case of subordinate officers of the Police Force and the Excise Department when an officer's general conduct has been good, and the "reduction" may be viewed in the same light as a reprimand would be in the ordinary civil service the pension may be computed on the average salary of the last three years, although the "reduction" may have taken place within that time and the officer may not have been reinstated.
- •41. No pension or gratuity granted under these rules shall be assignable or transferable.
- 42. If any person to whom a pension has been granted under these rules becomes a bankrupt the pension shall forthwith cease; but it shall be lawful for the 'Permanent Secretary, Ministry of Public Administration, Local Government and Home Affairs from time to time during the remainder of such pensioner's life or during such shorter period or periods either continuous or discontinuous as such 'Permanent Secretary, Ministry of Public Administration, Local Government and Home Affairs shall think fit, to pay all or any part of the moneys to which such pensioner would have been entitled by way of pension had he not become a bankrupt, or to apply the same for the maintenance and personal support or benefit of all or any, exclusive of the other or others of the following persons: namely, such pensoiner and any wife, child, or children of his in such proportions and manner as such 'Permanent Secretary, Ministry of Public Administration, Local Government and Home Affairs from time to time thinks proper.

There shall be deducted from the amount of any pension, annuity, allowance or gratuity payable under these Minutes to any public servant or any person who has retired from public service, any over-payment made to him out of Government funds or any sum or sums due from such public servant to the Government or to the Lady Lochore Loan Fund or any surcharge imposed on such public servant in respect of negligence or irregularity on his part during his period of service under Government.

Ex-gratia Gratuities

*44. Gratuities may be granted on retirement to deserving public servants and daily-paid employees in cases which are not otherwise provided for in this Minute and gratuities may be granted to the dependents of deceased public servants and daily-paid employees in cases not otherwise provided for in this Minute, or in the Ordinances providing for the granting of pensions to the Widows and Orphans of deceased public servants and daily-paid employees, provided that in no case shall the amount of such gratuity exceed Rs. 600.

in the service of which he was last employed before so serving or of the Secretary of State, the following provisions shall have effect:—

- (1) During the period of such service in His Majesty's Forces, including any period after the termination of the war (in this section referred to as "Military service"), he shall be deemed for the purpose of these rules to have been on leave on full salary from the public service in which he was last employed, and to have held the substantive office last held by him in that service, prior to military service.
- (2) During any period between his leaving the public service for the purpose of serving in His Majesty's Forces and the date of his commencing military service, he shall, for the purposes of these rules, be deemed to be on leave without salary, not granted on grounds of public policy, from the public service in which he was last employed, and to have held the substantive office last held by him in that service, prior to military service; and during any period between the termination of his military service and the date of his re-entering the public service he shall, for the said purposes, be deemed to be on leave as aforesaid from the service, and to have held the substantive office in which he is re-employed:

- (a) this section shall not apply when either period mentioned in paragraph (2) of this section exceeds three months, or such long period as the Governor may in any special case determine; or if the officer fails, after serving with His Majesty's Forces, to re-enter the public service otherwise than in circumstances in which he would be permitted, under the law applicable to the public service in which he is last employed prior to military service, to retire on pension or gratuity, such circumstances arising not later than the expiration of three months, or such longer period as may be determined as aforesaid, after the termination of his military service;
- (b) if during any period mentioned in paragraph (1) of this section the officer shall have qualified for pension, or received emoluments in lieu of pension rights, actually in respect of military service, paragraph (1) of this section shall, as respects that period, have effect as if the words "leave without salary, not granted on grounds of public policy" were substituted for the words "leave on full salary";
- (c) if during his military service the officer shall be injured or killed, he shall not, for the purposes of sections 30 and 31 of these rules be deemed to have been injured or killed in the discharge of his duty;
- (d) the provisions of this section which require that the officer shall be deemed to have held a specified office and to have been on leave from a specified service shall not apply in respect of any period during which he shall actually have held any other substantive office and have been on leave from any public service;
- (e) if any officer who was last employed in the public service of Ceylon prior to military service during the period referred to in paragraph (1) or the first period referred to in paragraph (2) of this section is promoted, and if such officer shall before re-entering the public service retire in circumstances in which he is permitted to retire on pension or gratuity, or if he shall die before re-entering the public service, he shall be deemed for the purposes of these rules to have held the substantive office to which he shall have been promoted from the date of such promotion.

Service as Teacher

- ²47. (i) Where an officer's Government service in a post or posts specified in Schedule D is continuous with recorded service (as defined in Teachers' Pension Rules) as a teacher in a School or Schools (irrespective of the order in time of either description of service) such service in a School or Schools shall be counted as Government service for purposes of determining whether he is qualified for a pension or gratuity under these rules by age, length of service, and the circumstance of his retirement or, when such officer dies in Government service, whether his dependants are qualified for a death gratuity under section 2B of these rules by his length of service.
 - (ii) The pension or gratuity of such an officer shall be calculated in accordance with such of the principles and methods prescribed in these rules as are not inconsistent with provisions of this section. The pension of such an officer shall be 1/720th of the officer's salary for each month of service in a post or posts specified in Schedule D plus an addition as climate bonus which shall bear the same proportion to 60/720ths of such salary as his service in a post or posts specified in Schedule D bears to the total of his contributory service in a School or Schools and the service under Government in a post or posts specified in Schedule D: Provided that no officer shall be eligible to receive the climate bonus unless the total of his contributory service in a School or Schools and his service under Government in a post or posts specified in Schedule D amounts to at least 120 months.
 - (iii) The total combined pensions for service under Government and in a School or Schools shall not exceed the maximum pension allowed by these rules. In any case falling under the limitation laid down in this sub-section the amount of pension to be drawn under these rules shall be determined by the "Permanent Secretary, Ministry of Public Administration, Local Government and Home. Affairs with due regard to the amount of any pension or pensions to be drawn in respect of any service in a School or Schools.
 - '(iv) In applying the provisions of this section to any person who held the post of a teacher in a Government school prior to June 15, 1934, the word "school" shall be read as not including a Government school.
 - 6 (v) A period of Government service in a post or posts specified in Schedule D and a period of recorded service (as defined in the School Teachers' Pension Rules) shall, notwithstanding any break between such periods, be deemed to be a single period of continuous service for the purposes of this section, and to constitute unbroken service for the purposes of section 20, if the break between such periods is due to causes beyond the officer's control and if the duration of that break does not exceed two years.
 - '(vi) The total amount which a person referred to in sub-section (i) may receive as climate bonus under these sections and under the School Teachers' Pension Rules (published in Gazette No. 7,631 of February 24, 1928) shall not in the aggregate exceed 5/60ths of his salary.

(a) his Provident Fund service is terminated by resignation made with consent given, under any written law or rule applicable to that Fund, for the purpose of enabling him to accept the pensionable office; and

- (b) the period intervening between the date of the termination of his Provident Fund service and the date of his entering on the duties of the pensionable office is not more than thirty-one days exclusive of any period during which he is actually being trained for such office.

(b) Where any public servant has retired after January 1, 1946, but on or before April 1, 1955, and the pension awarded to such public servant has been computed on a rupee scale of salary drawn at the date of his retirement, or where a pension has been awarded under section 31 of these Minutes to the dependants of any public servant who died after January 1, 1946, but are a before April 1, 1965, and public servant who died after January 1, 1946, but on or before April 1, 1955, and such pension has been computed on a rupee scale of salary drawn at the date of his death, such pension shall, subject to the provisions of paragraph (c) of this Schedule, be increased in accordance with the provisions of the Table set out hereunder.

Table

- (i) Where the basic pension (un-reduced) is less than Rs. 50 per mensem
- (ii) Where the basic pension (unreduced) is not less than Rs. 50 per mensem but less than Rs. 100 per mensem

(iii) Where the basic pension (un-reduced) is not less than Rs. 100 per mensem but less than Rs. 300 per mensem

(iv) Where the basic pension (unreduced) is not less than Rs. 300 per mensem but less than Rs. 500 per mensem

(v) Where the basic pension (unreduced) is not less Rs. 500 per mensem

The pension shall be increased by an amount equal to the basic (unreduced) monthly pension subject to a maximum increase of Rs. 2.50 per mensem.

The pension shall be increased by an amount equal to five per centum of the amount of such pension.

The pension shall be increased by an amount equal to three per centum of the amount of such pension.

The pension shall be increased by amount equal to two centum of the amount of such pension.

The pension shall be increased by amount equal to one per centum of the amount of such pension subject to a maximum increase of Rs. 12.50 per mensem.

(c) Where the amount to which a pension may be increased in accordance with the foregoing Tables is less than the amount to which that pension might have been increased if it had been smaller, that pension may be increased to the lastmentioned amount.

SPECIAL REGULATIONS REGARDING THE GRANT OF PENSIONS AND GRATUITIES TO PUBLIC OFFICERS RETIRING UNDER ARTICLE 63 OF THR CEYLON (CONSTITUTION AND INDEPENDENCE) ORDERS IN COUNCIL, 1946 AND 1947*

1. (a) In these regulations, unless the context otherwwise requires-

"Officer in the public service" means an officer who is either confirmed in, or occupies in terms of an agreement, a permanent office in the service of the Government of Ceylon which is separately provided for in the Estimates and has been declared to be pensionable by a notification published in the Government Gazette, and who belongs to any one of the classes of officers in the public service described in Section 63 (1) of the Ceylon (Constitution) Order-in-Council, 1946.

"Minutes on Pensions" in the case of an officer referred to in Section 63 (1) (a) of the Ceylon (Constitution) Order-in-Council, 1946, means the Minutes on Pensions in force on the 11th July, 1931, and in the case of an officer referred to in Section 63 (1) (b) or (c) of that Order-in-Council, means the Minutes on Pensions in force on the date of the first meeting of the House of Representatives.

- (b) Otherwise the terms used in these regulations shall have the meaning which they bear in the Minutes on Pensions, unless that meaning is inconsistent with the context.
- 2. (1) Subject to the exceptions and provisions contained in these regulations every officer in the public service who shall retire under Section 63 of the Ceylon (Constitution) Order-in-Council, 1946, may be granted the award which he might receive under the section (or sections) of the Minutes on Pensions which would be appropriate to his case if his retirement were necessitated by illness and, in addition thereto, a compensatory pension calculated in accordance with the following provisions:—
- (i) An officer who at the date of his retirement has completed not less than 120 months gross service may be granted a compensatory addition as under—
 - (a) If his age at retirement is less than 43 years and not less than 40 years, he may receive an addition of 90/720ths of his salary.
 - (b) If his age at retirement is 43 years or over, he may receive an addition of so many 720ths of his salary as there are complete periods of two months in the period by which his age at retirement falls short of 58.
 - (c) If his age at retirement is less than 40 years, he may receive an addition of so many 720ths of his salary as there are periods of two months in the period by which his age at retirement exceeds 25.
- (ii) An officer who at the date of his retirement has completed less than 120 months gross service may receive a compensatory addition of so many 720ths of his salary as there are complete periods of 2 months in the period of his service counting for pension, provided that the number of 720ths of salary comprising the compensatory addition shall in no case exceed the number of months in the period by which his age at retirement falls short of 55.

Provided that in applying the provisions of this regulation to any European Matrons, Assistant Matrons, and Nursing Sisters—

- (i) "90/720ths" in paragraph (1) (i), (a) shall be read as "60/720ths".
- (ii) The age limit of "58" in paragraph (1) (i), (b) shall be read as "53".
- (iii) The age limit of "55" in paragraph (1) (ii) shall be read as "50".
- (2) Any officer, whatever his length of service, retiring under Section 63 of the Ceylon (Constitution) Order-in-Council, 1946, may elect to receive, in lieu of the total award which he might receive under paragraph (1) of this regulation, the pension or gratuity which he might have received under Section 7 or, if applicable, Section 21 of the Minutes on Pensions if at the date of his retirement he had been compelled to retire by reason of the abolition of his office.

For the purpose of this paragraph the pension which an officer might have received as aforesaid under the said Section 21 shall, if it be to his advantage, be deemed to be the aggregate of the following amount:—

- (i) a pension calculated under Section 21, no regard being had, in calculating the pension to which he would have been entitled had the whole of his service been under the Government of Ceylon, to Section 7;
- (ii) an amount equivalent to that by which his pension calculated in accordance with Section 2 would have been increased under the said Section 7 by reason of abolition of office if his whole service had been under the Government of Ceylon.
- (3) For the purposes of this regulation the expression "Minutes on Pensions" shall be construed as if Section 28 of the Minutes on Pensions as amended by Notification dated January 23, 1937, had been in force before the 11th of July, 1931.
- 3. (1) An Officer retiring under Section 63 of the Ceylon (Constitution) Order-in-Council, 1946, may elect to receive in lieu of a pension calculated under regulation 2 a pension at the rate of three-fourths of such pension together with a gratuity equal to the reduction so made multiplied by the number of years purchase indicated in the following table:—

Provided that the number of years' purchase for European Matrons, Assistant Matrons, and Nursing Sisters retiring at any age shall be 10.

- (2) An officer desiring to receive a reduced pension and gratuity calculated in the manner prescribed in the preceding paragraph must notify his election under that paragraph to the Deputy Secretary to the Treasury in Ceylon or the Authorized Representative of the Government of Ceylon within one month from the date on which the notification of his decision to retire is received in the office of the Secretary to the Treasury or in the Office of the Authorized Representative of the Government of Ceylon, as the case may be, and he will not thereafter be permitted to elect for a reduced pension and gratuity under the preceding paragraph unless the Secretary to the Treasury shall for special reasons order otherwise, but in no case shall effect be given to an election made after an officer has begun to draw pension.
- (3) Where an officer is granted under paragraph (1) of this regulation both a gratuity and reduced pension, the amount of pension shall be deemed for the purpose of calculating any deduction from the pension which is required to bring it within the limit prescribed by regulation 8 of these regulations, to be the amount of the pureduced pension which might have been granted if the option of commutation had not been exercised.
- '4) For the purpose of this regulation, the word "pension" is to be interpreted as including a retiring allowance granted under regulation 4 of these regulations.

- 4. If an officer in the public service drawing as salary at a yearly or monthly rate whose service has been entirely in a non-pensionable office and who belongs to any one of the classes described in Section 63 (1) of the Ceylon (Constitution) Order-in-Council, 1946, elects to retire under that section he may be granted such retiring allowance as he might have been granted under Section 27 of the Minutes on Pensions as it read on 31st December, 1945. if at the time of his retirement he had been compelled to retire by reason of the abolition of his office.
- 5. For the purpose of computing the compensatory addition granted under these regulations, the service of an officer transferred to the public service of the Government of Ceylon from other service under the Crown shall include such other service if it is continuous with his service under the Government of Ceylon.
- 6. Any period during which an officer absent on leave from the Island has, with the consent of the Governor or the Secretary of State, served with His Majesty's armed forces during the War of 1914-1921, or in any other capacity connected with the state of war, may be counted as service on full-pay for the purpose of these regulations.
- 7. If any officer of the Ceylon Civil Service who received his first appointment under the post-war reconstruction scheme after serving with His Majesty's armed forces during the War of 1914-1921 shall elect to retire under Section 63 of the Ceylon (Constitution) Order-in-Council 1946, the period, intervening between the completion of the 23rd year of his age or the date on which he began his war service (whichever is later), and the date on which he received his appointment as a Cadet shall be counted as leave on full-pay for the purpose of computing the total pension grantable under these regulations.
- 8. In no case shall a pension granted under these regulations exceed two-thirds of the highest pensionable emoluments drawn by an officer at any time in the course of his service under the Government of Ceylon.
- 9. The mode of calculating awards granted under these regulations shall be that which is prescribed in Section 8 of the Minutes on Pensions for pensions or gratuities awarded under those Minutes.
- 10. (1) If an officer is in Ceylon when he decides to retire under Section 63 of the Ceylon (Constitution) Order-in-Council, 1946, he shall notify the Secretary to the Treasury, through the Head of his Department and the Permanent Secretary to the Ministry, in writing of his decision, stating at the same time the date on which he desires to begin such leave preparatory to retirement as he may be allowed under the regulations of Government relating to the grant of such leave. In no case, however, unless the Secretary to the Treasury for special reasons orders otherwise, shall an officer, who is in Ceylon when he notifies his decision to retire be permitted to retire or go on leave preparatory to retirement before three months have elapsed from the date on which the written notification of his intention to retire is received by the Secretary to the Treasury.
- (2) If an officer decides to retire under Section 63 of the Ceylon (Constitution) Order-in-Council 1946, when he is out of Ceylon on half-pay (or commuted half-pay) leave or on combined vacation and half-pay (or commuted half-pay) leave, he shall notify the Authorized Representative of the Government of Ceylon (or if it is more convenient the Secretary to the Treasury) in writing of his decision, stating at the same time whether he elects that his retirement should take effect from the date on which such leave preparatory to retirement as he might have received at the commencement of his leave expired (or will expire) or whether he elects that his retirement should take effect as from the date on which his written notification is received in the Office of the Authorized Representative of the Government of Ceylon (or the Office of the Secretary to the Treasury if his notification has been addressed to him). Unless it shall in any particular instance appear to the Governor contrary to the public interest, the date of retirement shall be determined in accordance with the officer's election, but if he elects the second alternative he shall be required to refund any salary in excess of half-pay which he may have drawn subsequent to the date on which such leave preparatory to retirement as he might have received at the commencement of his leave would have expired.

Provided always that if an officer who is referred to in section 63 (1) (b) or (c) of the Ceylon (Constitution) Order-in-Council, 1946, and who is out of the Island on half-pay (or commuted half-pay) leave or combined vacation and half-pay (or commuted half-pay) leave on the date of the first meeting of the House

of Representatives, elect to retire during his leave then current, he may do so with effect either from the date on which the written notification of his decision is received in the office of the Authorized Representative of the Government of Ceylon (or the Office of the Secretary to the Treasury if his notification has been addressed to him) or from the day succeeding the date of the first meeting of the House of Representatives, but in either case he will be required to refund any calary in excess of half-pay which he has drawn between the date on which such leave preparatory to retirement as he might have received at the commencement of his leave expired, and the date on which his retirement takes effect.

11. Unless he refunds the cost of the outward passage (or passages) to Ceylon granted to him and any salary in excess of half-pay drawn by him during the period subsequent to the date on which such leave preparatory to retirement as he might have been granted at the commencement of his leave would have expired, an officer returning from leave to Ceylon after the date of these regulations who decides to retire under Section 63 of the Ceylon (Constitution) Order-in-Council, 1946, shall not be permitted to retire or go on leave preparatory to retirement until he has service for at least one year from the date of his return. It, however, the Secretary to the Treasury for special reasons so orders, such an officer may be permitted to begin his leave preparatory to retirement at an earlier date and the requirement relating to the refund of half salary and the cost of outward passages may be wholly or partially remitted according as the Secretary to the Treasury may in any particular case determine.

12. The passage grants to an officer retiring under Section 63 of the Ceylon (Constitution) Order-in-Council, 1946, will be governed by the rules relating to passages on retirement in force at the date of the officer's retirement.
