##### MINUTES ON PENSIONS

NOTICE under Minutes on Pensions issued on February 05, 1934 and section 31 of Minutes on Pensions (amended) May 05, 1972.

##### Notice

The Minutes on pensions as amended from time to time is further amended by insertion of following proviso immediately after the Section 31 'C' of the minutes on pensions.

Disability pension may be paid to personal serving in any rank of the Police Department who have become disabled consequent to injuries sustained in action against terrorism or in enforcing law and order upon the percentage of loss of their earning capacity.
