Pensioners' Life Certificate – 2021

The required specimen form of Pensioners' Life certificate, for the consecutive year 2021 is forwarded herewith. You are kindly informed to prevent the acceptance of any other specimen formats except the given specimen for the year 2021.

- O2. Your attention is drawn to the section 08 of this specimen. Accordingly it is mandatory to enter the information of the guardians for the pensions that are payable through guardians. Further the relevant life certificate shall be filled into the pensioners' file with a record immediate after the insertion of the said specimen into your computer system.
- 03. Following shortcomings have been discovered during the audit inspection when obtaining the life certificates; accordingly actions should be taken to rectify those situations. Therefore,
 - I. Ensure whether the National Identity Card number is compulsorily inserted and it's correct.
 - II. The signature and date of the pensioner is mandatory and should be attested by Grama Niladhari placing signature included official seal.
- III. The reason shall be included as a special note by the Grama Niladhari in the format, when a life certificates are marked with fingerprints instead of signature.
- IV. Life certificates shall be updated in the data system before 31.03.2021. It is informed the salaries of those pensioners whose life certificates have not updated by the said date will be suspended by May 2021.
- 04. Additionally, your attention is drawn to the letter of Secretary of Ministry of Internal and Home Affairs and provincial Councils and Local Governments No.HAF-2/15 CORDI/1507-(SUB I) dated 06.11.2019 on the actions taken when obtaining the life certificate form clergies.
- 05. Furthermore, it is not required to obtain the life certificate from pensioners who use digital life certificate system according to pension circular 2/2020.
